One of our RWF Presidents, Susan St Peters from the San Clemente RWF, posed a brilliant perspective in her Club's President's letter this week and we would like to share her insights to inspire and strengthen us ALL so we can continue to lead and endure through this dark time.

“A Light in the Darkness”

“Even the tiniest pinprick of light is visible in complete darkness. In fact, light that shows up in a darkened room might go unnoticed in mere twilight or semi-darkness. I was reminded of this phenomenon while with my husband at the ophthalmologists recently. As the room plunged into darkness, my eyes were immediately drawn to the small sliver of light directed by the doctor. Its presence was unmistakable and pierced the darkness.

The power of illumination is also evident in our fight against the dark forces confronting us today: socialism, totalitarianism, cancel culture, critical race theory, and the list goes on. These things threaten to overwhelm us, yet they cannot stand to be scrutinized in the light. While not all dark threats are completely neutralized by being brought out into the light, at the very least exposure reveals the truth of what we are facing. And when truth is revealed, we can more adequately strategize how to best combat the monsters with which we do battle. Shining the light of truth upon them reveals their massiveness, their ugliness, and their ferocity but also their weaknesses and vulnerabilities.

How do we turn on the light? By becoming informed, by being reminded that we are not in this battle alone, and by facing our fears rather than cowering

before them. Keep in mind what “woke culture” does to anyone who is shamed into changing a stance and apologizing; enough is never enough. The attacks don’t stop until the target is eliminated (and opposers of “wokeness” are targets that cancel culture sniper-like warriors relentlessly pick off one by one). And if we give in to fear and allow ourselves to be silenced, our light is dimmed, often extinguished.

Some lights have been turned on in recent days, and in those lights, we should find great hope, as they put paid to the Left’s lie that the darkness is impenetrable. The successful recall of California Governor Gavin Newsom is one such light. The on-going ballot audit in Arizona is another (which, btw, anyone can watch live at **DefendingTheRepublic.org** . The Left is fighting hard to stop it, which raises the question, “What don’t they want exposed?” Mike Lindell’s latest film Absolute Interference, available for free at <https://www.frankspeech.com>, is yet another. All around us, brave patriots confront the darkness and boldly shine the light of truth. For example, Senator Tim Scott, in his response to Imposter-in-Chief’s recent speech, dared to speak these words of truth: “Hear me clearly: America is not a racist country. It’s backwards to fight discrimination with different types of discrimination.” And this week, Florida Governor Ron DeSantis stood up for Americans’ rights “to participate in society, go to a restaurant, movie, a ballgame, all these things without having to divulge th[e] type of information” that a vaccine passport would require.

Light exposes evil deeds and lies, while at the same time attracting those who practice truth. When the truth about what is being taught in schools finally came to light, parents, grandparents, and other concerned citizens started getting more involved in their children’s education and standing up to the School Boards and Teachers’ Unions, thus threatening the Left’s ability to brainwash another generation of students. And the more the truth about what’s taught under the guise of education is exposed, the more people are willing to be the light and stand against such darkness. Those who love the darkness hate the light because they fear exposure. John 3:19-21 reminds us, “...men loved the darkness rather than the Light, for their deeds were evil. For everyone who does evil hates the Light and does not come to the Light for fear that his deeds will be exposed. But he who practices the truth comes to the Light.”

Shining the light of truth in the darkness and being the light that people of faith are called to be is hard. Matthew 5:14 tells Christians, “You are the light of the world,” and Matthew 5:16 urges believers to “Let your light shine before men in such a way that they may see your good works and glorify your Father who is in heaven.” The command is clear, but following it requires that we put aside our fears of what might happen to us if we obey. By “being a light”, we may open ourselves up to ridicule, harassment, or persecution, even physical danger. No one willingly seeks those things. But hiding in the darkness does not save us from being enveloped by it. And make no mistake, those who oppose us and what we stand for will try to take us out. But if the darkness grows, its adherents will come for us whether or not we act as light because they oppose not just our views but our very right to exist. Instead of living in darkness and fear, we must go on the offensive. Instead of being afraid that those who love darkness will find us, we need to be the light that exposes them, their deeds, and their weaknesses, so that they can be stopped. Instead of our fearing them,

those who love the darkness should fear us because true power lies in the very source of our Light, “the Light of the world” as described in John 8:12. Something to think about next time your hand is on a light switch.”

2020 Census Population Reapportionment

This year for the first time in California’s history, the state has lost a representative. These reasons may be why: California has the highest income tax, state sales tax, and gas tax. Our poverty rate, when the cost of living is taken into account, is the highest in the nation. Our unemployment rate is higher than nearly every other state. According to California Globe, the state of California is ranked #50 (again) as worst in Chief Executive Mag’s Best & Worst States for Business 2021.

Other states that **lost** a representative are: **Michigan, Ohio, Illinois, Pennsylvania, New York, and West Virginia**. States that **gained** a representative are: **Florida, Colorado, North Carolina, Montana, and Oregon**. **Texas** gained two representatives.

Information Regarding the California School Choice Initiative

Hello Friends,

Have you ever wished your children and grandchildren could attend a California school that teaches values aligned with yours? A school that doesn't indoctrinate students in critical race theory, or a failed common core math curriculum, or graphic sex education lessons.

One thing parents have learned this year is California's 10,000 schools remained closed or only partially open *because the teachers unions simply wouldn't permit allowing children to return*. Parents also learned that the system cannot be effectively reformed from the outside--via legislative or school board action because *their* constituents are the unions and the union money that put them in office.

The only solution is to take your children, take your money and go somewhere else. But how? Have you heard about the **California School Choice Initiative**? It has four key provisions:

1. An Education Savings Account (ESA) would be created for every K-12 student in California.
2. These accounts would be created annually with each student's pro-rata share of Prop. 98 funds, approximately \$12,000 per student per year.
3. Parents of K-12 students will be able to direct that money to a participating school, whether it's a public, charter, or accredited private or parochial school.

4. If unspent, the money would accumulate to be used for college, vocational or any other accredited educational expense.

The School Choice Initiative will be in full swing in September when we have the green light to collect 1,500,000 signatures in 180 days to place this initiative on the 2022 ballot. I hope you will have a chance to read the links in this email and become informed because this is a rare opportunity to change the course of our children's education for many generations.

Dear Patriot --

First of all, I want to thank you for all of your support over the last two years. Because of you, the issue of school choice -- to say nothing of the outrageous behavior of the teachers' unions -- is now the hottest issue in California.

Support for our school choice amendment has increased exponentially. We are in the final drafting stages of our school choice initiative. We anticipate having approval to gather signatures by the first part of September.

Once we get the AG's letter, we will have 180 days/25.7 weeks to gather 1.0 million valid signatures. Our goal will be 1.5 million to make sure no one can play with our numbers.

Critical Race Theory: What it is and How to Fight It

The following is adapted from a lecture delivered at Hillsdale College on March 30, 2021.

Critical race theory is fast becoming America's new institutional orthodoxy. Yet most Americans have never heard of it—and of those who have, many don't understand it. It's time for this to change. We need to know what it is so we can know how to fight it.

In explaining critical race theory, it helps to begin with a brief history of Marxism. Originally, the Marxist Left built its political program on the theory of class conflict. Marx believed that the primary characteristic of industrial societies was the imbalance of power between capitalists and workers. The solution to that imbalance, according to Marx, was revolution: the workers would eventually gain consciousness of their plight, seize the means of production, overthrow the capitalist class, and usher in a new socialist society.

During the 20th century, a number of regimes underwent Marxist-style revolutions, and each ended in disaster. Socialist governments in the Soviet Union, China, Cambodia, Cuba, and elsewhere racked up a body count of nearly 100 million of their own people

By the mid-1960s, Marxist intellectuals in the West had begun to acknowledge these failures. They recoiled at revelations of Soviet atrocities and came to realize that workers' revolutions would never occur in Western Europe or the United States, where there were large middle classes and rapidly improving standards of living. Americans in particular had never developed a sense of class consciousness or class division. Most Americans believed in the American dream—the idea that they could transcend their origins through education, hard work, and good citizenship.

But rather than abandon their Leftist political project, Marxist scholars in the West simply adapted their revolutionary theory to the social and racial unrest of the 1960s. Abandoning Marx's economic dialectic of capitalists and workers, they substituted race for class and sought to create a revolutionary coalition of the dispossessed based on racial and ethnic categories.

WHAT IT IS

Critical race theory is an academic discipline, formulated in the 1990s, built on the intellectual framework of identity-based Marxism. Relegated for many years to universities and obscure academic journals, over the past decade it has increasingly become the default ideology in our public institutions. It has been injected into government agencies, public school systems, teacher training programs, and corporate human resources departments in the form of diversity training programs, human resources modules, public policy frameworks, and school curricula.

There are a series of euphemisms deployed by its supporters to describe critical race theory, including “equity,” “social justice,” “diversity and inclusion,” and “culturally responsive teaching.” Critical race theorists, masters of language construction, realize that “neo-Marxism” would be a hard sell. Equity, on the other hand, sounds non-threatening and is easily confused with the American principle of equality. But the distinction is vast and important. Indeed, equality—the principle proclaimed in the Declaration of Independence, defended in the Civil War, and codified into law with the 14th and 15th Amendments, the Civil Rights Act of 1964, and the Voting Rights Act of 1965—is explicitly rejected by critical race theorists. To them, equality represents “mere nondiscrimination” and provides “camouflage” for white supremacy, patriarchy, and oppression.

An equity-based form of government would mean the end not only of private property, but also of individual rights, equality under the law, federalism, and freedom of speech. These would be replaced by race-based redistribution of wealth, group-based rights, active discrimination, and omnipotent bureaucratic authority. Historically, the accusation of “anti-Americanism” has been overused. But in this case, it's not a matter of interpretation—critical race theory prescribes a revolutionary program that would overturn the principles of the Declaration and destroy the remaining structure of the Constitution.

HOW IT WORKS

What does critical race theory look like in practice? Last year, I authored a series of reports focused on critical race theory in the federal government. The FBI was holding workshops on intersectionality theory. The Department of Homeland Security was telling white employees they were committing “microinequities” and had been “socialized into oppressor roles.” The Treasury Department held a training session telling staff members that “virtually all white people contribute to racism” and that they must convert “everyone in the federal government” to the ideology of “antiracism.” And the Sandia National Laboratories, which designs America’s nuclear arsenal, sent white male executives to a three-day reeducation camp, where they were told that “white male culture” was analogous to the “KKK,” “white supremacists,” and “mass killings.” The executives were then forced to renounce their “white male privilege” and write letters of apology to fictitious women and people of color.

In Cupertino, California, an elementary school forced first-graders to deconstruct their racial and sexual identities, and rank themselves according to their “power and privilege.” In Springfield, Missouri, a middle school forced teachers to locate themselves on an “oppression matrix,” based on the idea that straight, white, English-speaking, Christian males are members of the oppressor class and must atone for their privilege and “covert white supremacy.” In Philadelphia, an elementary school forced fifth-graders to celebrate “Black communism” and simulate a Black Power rally to free 1960s radical Angela Davis from prison, where she had once been held on charges of murder. And in Seattle, the school district told white teachers that they are guilty of “spirit murder” against black children and must “bankrupt [their] privilege in acknowledgement of [their] thieved inheritance.”

Second, critical race theorists have constructed their argument like a mousetrap. Disagreement with their program becomes irrefutable evidence of a dissenter’s “white fragility,” “unconscious bias,” or “internalized white supremacy.”

When I say that critical race theory is becoming the operating ideology of our public institutions, it is not an exaggeration—from the universities to bureaucracies to k-12 school systems, critical race theory has permeated the collective intelligence and decision-making process of American government, with no sign of slowing down.

FUTILE RESISTANCE

Thus far, attempts to halt the encroachment of critical race theory have been ineffective. There are a number of reasons for this.

First, too many Americans have developed an acute fear of speaking up about social and political issues, especially those involving race. According to a recent Gallup poll, 77 percent of conservatives are afraid to share their political beliefs publicly.

Second, critical race theorists have constructed their argument like a mousetrap. Disagreement with their program becomes irrefutable evidence of a dissenter’s “white fragility,” “unconscious bias,” or “internalized white supremacy.”

Third, Americans across the political spectrum have failed to separate the premise of critical race theory from its conclusion. Its premise—that American history includes slavery and other injustices, and that we should examine and learn from that history—is undeniable. But its revolutionary conclusion—that America was founded on and defined by racism and that our founding principles, our Constitution, and our way of life should be overthrown—does not rightly, much less necessarily, follow.

Fourth, the writers and activists who have had the courage to speak out against critical race theory have tended to address it on the theoretical level, pointing out the theory’s logical contradictions and dishonest account of history. These criticisms are worthy and good, but they move the debate into the academic realm, which is friendly terrain for proponents of critical race theory. They fail to force defenders of this revolutionary ideology to defend the practical consequences of their ideas in the realm of politics.

POLITICAL ENGAGEMENT

No longer simply an academic matter, critical race theory has become a tool of political power. More and more, it is driving the vast machinery of the state and society. If we want to succeed in opposing it, we must address it politically at every level.

There are three parts to a successful strategy to defeat the forces of critical race theory: governmental action, grassroots mobilization, and an appeal to principle.

Last year President Trump issued an executive order banning critical race theory-based training programs in the federal government. President Biden rescinded this order on his first day in office, but it provides a model for governors and municipal leaders to follow. This year, several state legislatures have introduced bills to achieve the same goal: preventing public institutions from conducting programs that stereotype, scapegoat, or demean people on the basis of race. And I have organized a coalition of attorneys to file lawsuits against schools and government agencies that impose critical race theory-based programs on grounds of the First Amendment (which protects citizens from compelled speech), the Fourteenth Amendment (which provides equal protection under the law), and the Civil Rights Act of 1964 (which prohibits public institutions from discriminating on the basis of race).

On the grassroots level, a multiracial and bipartisan coalition is emerging to do battle against critical race theory. Parents are mobilizing against racially divisive curricula in public schools and employees are increasingly speaking out against Orwellian reeducation in the workplace.

In terms of principles, we need to employ our own moral language rather than allow ourselves to be confined by the categories of critical race theory. For example, we often find ourselves debating “diversity.” Diversity as most of us understand it is generally good, all things being equal, but it is of secondary value. We should be talking about and aiming at excellence, a common standard that challenges people of all backgrounds to achieve their potential. On the scale of desirable ends, excellence beats diversity every time.

We must promote the true story of America—a story that is honest about injustices in American history, but that places them in the context of our nation’s high ideals and the progress we have made towards realizing them. Genuine American history is rich with stories of achievements and sacrifices that will move the hearts of Americans—in stark contrast to the grim and pessimistic narrative pressed by critical race theorists. Above all, we must have courage—the fundamental virtue required in our time. Courage to stand and speak the truth. Courage to withstand epithets. Courage to face the mob. Courage to shrug off the scorn of the elites. When enough of us overcome the fear that currently prevents so many from speaking out, the hold of critical race theory will begin to slip. And courage begets courage.

Truth and justice are on our side. If we can muster the courage, we will win
