If we have any hope to "solve" the homeless problem, we must give some thought to its causes. It is deceptively easy to see the problem as one of access to resources, with job loss, the cost of housing or a death in the family being the most likely circumstances leading to homelessness. Homelessness, however, has a darker side to it; drug and alcohol abuse and an actual desire to stay homeless is at the core of it.

The idea of homelessness being a lifestyle choice is difficult for most of us to understand, but understanding the truth of this concept will help us all make decisions about the kinds of solutions that will result in meaningful change. It is also important to understand that the California Legislature has pushed an ideology that does little to moderate homelessness and much to propagate it. The explosion of homelessness that we as a region have experienced over the past two years can be directly linked to out-of-control substance abuse and a legislative agenda in Sacramento that is heavy with unintended consequences, making the homeless problem much worse.

It all started with Assembly Bill 109, passed in 2011 . The idea of "realignment" was to ease

prison overcrowding in California by simply deciding that many crimes were no longer punishable by incarceration. More than 70 crimes were redefined as "less serious" or "nonviolent." This began in 2015, and since then my city of El Cajon, has seen a 35 percent increase in homelessness. Many beach communities have seen well over 100 percent increases. Sacramento will say that there is no correlation, but that defies logic. In San Diego County alone, 7,619 probationers were released into the county, with 1,077 being homeless upon release. Approximately 10 percent of the homeless in our region were prisoners on an early release program.

Next, **Proposition 47 was approved in 2014**. This law converted a series of crimes from felonies to misdemeanors. Again, this is designed to keep people out of prison, but it has many unintended consequences. Proposition 47 also makes shoplifting of items less than \$950 a misdemeanor. Recently I had a group of 7-Eleven owners in my office complaining that the homeless stole from them with impunity, and no fear of the police. Proposition 47 also makes personal use of most drugs a minor offense; subject to a ticket or more likely no enforcement. Honest assessments conclude that over 90 percent of homeless people are using drugs or alcohol. Over the past two years there has been a flood of powerful but cheap drugs, mostly methamphetamines, which have been thrust into our culture causing mass addiction, disability and dropping out of society.

In 2017, the Legislature passed Senate Bill 180, which limits the ability of law enforcement to send chronic drug abusers back to prison. A recent court case limited law enforcement's ability to stop people from living in their cars.

In 2015, a Supreme Court case limited a city's ability to criminalize panhandling. Cities cannot enforce vagrancy laws unless they have cooperation from the District Attorney's Office, which that office is loath to provide. Cities are constantly under pressure from the ACLU and local grand juries to open the parks for the homeless, allow tent cities and refrain from "harassing the homeless." So enforcement is difficult at best. If the police do arrest a homeless person and that person has a shopping cart of possessions, the police are obligated to catalog and store these possessions regardless of worth.

Sacramento's approach to this problem is one of normalizing homelessness. The idea is to accept mass homelessness as just a part of any society. The thrust of the fight has been one of permissiveness and rejection of value judgments that might shame the homeless, or pressure them out of the homeless lifestyle.

In parallel, the Legislature has made the same arguments toward drug and alcohol addiction and criminality. It is up to the public to accept or reject this approach. It seems clear to me that to accept this, however, is to accept the recent increase in homelessness as a reality that is here to stay and likely to grow.

In any event, I contend that local government has little to do with the increase in homelessness. It is the California Legislature that has designed this problem and it will have to be the California Legislature that designs the solution.

Dear NFL players who are choosing to kneel for the National Anthem,

Congratulations—you've got our attention. You've opened up a debate in this country, to be sure. The only problem is that, unfortunately, you've opened up the wrong debate. It was understood by many that your goal was to protest racial inequality. Unfortunately, you've provided the public with little information other than that you are protesting and you want change. The problem is that when you are trying to lead by sitting or taking a knee, you aren't leading in an active way that creates change. At best, you are making a passive demonstration, which gains our attention, but which alone can rarely bring about the change we are seeking.

You've successfully stirred up emotion, but to what end? People are debating, to be sure, but they're primarily talking about your First Amendment rights, whether or not you are respecting/disrespecting the flag/military, and President Trump's recent comments. The only measurable action steps that Americans have taken in response to your protests is that some are beginning to counter-protest by boycotting the NFL and refusing to watch or attend games. Was this your intention? I humbly suggest that you pause to reconsider the effects of your protests. While I speak to you as a military veteran, I strongly support your constitutional right to freedom of speech. At the same time, I am an Army Ranger, and we live by the creed that "I will shoulder more than my share of the task whatever it may be, one hundred percent and then some." Rangers are one of our military's most elite and effective forces BECAUSE we take action, and bear as much of the burden upon our own

shoulders as humanly possible. We don't voice our displeasure and then wait for someone else to do something: we do it. We make and create the change we want to see.

The time to protest is over. You have accomplished your mission, because you now have the attention of our nation, and our world. If your protests have achieved one thing, it is that they have given you the spotlight. Next, you need to start providing guidance on what needs to happen, showing people the solutions that you're looking for. What can you do, today, besides the 3 minutes it takes to protest the National Anthem to encourage greater racial equality? Use your fame and public platform to provide direction for your fans, and step out into your own communities. Contribute your time, sweat, and money to organizations that are advancing the causes that you believe in. Encourage your fans to do the same. We all have skills that we can bring to bear on making the world a better place. For example, I knew from my experience working in foreign communities overseas that I could volunteer to assist local law enforcement with strategies that would help them serve their communities more empathetically. I didn't protest the action; I saw the action and decided to do something to create change.

Right now, all that this protesting has done is lead to greater divisiveness in an already divided nation. What we need right now are leaders who are talking about and encouraging racial equality. I'm sure that many of your feel that you are leading by example. The problem is that leading by example isn't really leading at all. Leadership requires taking responsibility for other's actions, as well as your own. Set the example with action, and then lead by providing guidance. Lead with hope and trust, not

passivity and talk. Leading that way makes you no better than many politicians, who do nothing but talk. You are capable of so much more!

The NFL, like the military, is an organization where Americans of all creeds and colors come together in battle for shared victory. As teammates, you know what it looks like to work, sweat, and bleed beside your brothers of all races. Our military servicemembers and veterans live this same reality every day.

The NFL holds a great tradition in this country, an organization revered and enjoyed by many Americans. Don't use your position to divide us. I am honored to work with NFL players regularly, and I am inspired by how many players use their public platform for good. I hope you will join them in showing us how, in your own lives, by your own action, you're working to build racial equality. Show us how the NFL is a place where racial equality is an achievable reality that you live every day—and then work to continue that in your communities, as well. Be the example. It's time to stop protesting and shoulder your share of the task. I will do my part with you, and I am willing to rely upon your leadership to guide me.
