Keith Milton Moser, Junior

Private First Class

United States Marine Corps

Born 25 September 1946

Killed in Action 3 June 1967

Quang Tin, Vietnam

Keith Milton Moser, Junior, was born 25 September 1946, the son of Keith Moser and Janet Davidson Moser. Keith was one of 5 children with brothers John, Mark, Phillip and baby sister Mary Beth. Keith was born and raised in Michigan. The family moved to Bent Twig Lane in Tustin shortly before Keith's death.

Keith enlisted into the United States Marine Corps in Chicago, Illinois on March 17, 1966. He was assigned to Company F 2nd Battalion 5th Marines and sent to Vietnam.

During the beginning of June Company E and F were participating in Operation UNION II in Quang Nam and Quang Tin Provinces. On June 2 – 3, the Marines met stiff opposition from the north Vietnamese Army for invading their harbor sites in the Que Son and Thang Binh Districts. With Company D of the 1st Battalion engaged with the enemy, Company F advanced and was hit with a barrage of mortar, Rocket Propelled Grenades and automatic weapons fire from an enemy in fortified positions. The battle lasted throughout the day and into the night with heavy losses to the Marines. Thirty Marines were killed in action including the Company Commander who led a charge on a Command bunker during the battle, and fifty-nine men were wounded. PFC Keith Moser was one of the casualties, he was killed in action by hostile rifle fire.

Although relatively new to Tustin, PFC Keith Milton Moser II, was Tustin's first Vietnam Combat fatality. He was 20 years old. He is the recipient of the Purple Heart, Vietnam Service Medal National Defense Medal and the Vietnam Campaign Medal. He is buried at Holy Sepulcher Cemetery in Orange.



The Tragic Story of Evelyn Bennett Willard

Evelyn Bennett was born in Kansas in 1880 and by 1899 she was

living in Pomona when she married Charles Willard in Tustin. Charles was the co-owner of the Willard & Gowen Packing House and one of the founders of the Willard Brothers (which became the Tustin Water Works) Water Works. The Willards lived in comfort with their three daughters in a large house on the corner of Main and A Street in Tustin.

Sadly, Charles died in 1916 at the age of 50, probably from tuberculosis, then known as consumption. Evelyn and the girls remained at the house on Main Street, but Evelyn began to show signs of instability.

Living across the street was Charles Vance, the banker, and his family. One day Evelyn chased 12-year-old Louise Vance down the street with a butcher knife, screaming, "Children shouldn't have to live in this world!" Fortunately, young Louise was able to outrun her pursuer.

Shortly after this incident Evelyn Willard committed suicide in a horrible fashion. While standing in her front yard she doused herself with gasoline and lit a match. She immediately regretted her decision and attempted to put herself out with a garden hose. She then ran into the house and jumped in the bathtub. She was still there moaning in agony when her 17-year-old daughter, also named Evelyn, returned from school and found her there. The daughter ran across the street to the home of Charles Artz to seek help. A doctor was called but she was too badly injured to save. All her clothes had been burned off her body except for her shoes.

She was transported to the community hospital but passed away later that evening. While still conscious she said she was "tired of life and might as well be dead." She was just 41 years old and was buried beside her husband at Santa Ana Cemetery with a very modest headstone.

The family was dogged by tragedy. Oldest daughter, Valeda, was married in February 1927 and died two months later at the age of 27.

The youngest daughter June never married and by 1950 was an inmate of a state mental hospital in Placer County.

Only middle daughter Evelyn lived to a ripe old age, passing away in 1995 at the age of 92.

CITY OF TUSTIN'S HOUSING ELEMENT REZONE PROJECT AND ENDERLE CENTER

As many of you who live in Tustin know, the City of Tustin is finalizing its participation in a state-mandated project for all cities in California to re-zone areas to accommodate thousands of housing units state-wide. The City of Tustin must report to the state by February 2025 its approved re-zoned sites that would allow for a total of approximately 2,700 housing units to be built. Three sites have been proposed: Tustin Marketplace, Tustin Legacy, and Enderle Center. Final discussions on this project will take place at the **November 19th City Council Meeting, 300 Centennial Way, Tustin 92780, at 7:00 pm.**

Enderle Center (located on the south side of Seventeenth Street in Tustin, between Yorba and Enderle Center Drive) is currently in escrow which will soon close. The buyers are an upscale retail development company, Burnham-Ward Properties of Newport Beach. Nearby residents have naturally been concerned about the rezoning of this shopping center to allow a maximum of 413 housing units to be built there. However, the owner and a partner of Burnham-Ward Properties arranged for an informative meeting with concerned residents on November 7 at Zov's Restaurant (an anchor restaurant in Enderle Center). At this meeting, residents heard that the emphasis of the new owners is to improve and enhance Enderle Center so that it remains the upscale, high-end

center and community gathering place it has been for many years. While the number of housing units to be built was not confirmed at the meeting, the new owners emphatically stated that any housing units would be minimal and would not negatively impact the elegance of the rejuvenated Enderle Center.

Those attending the November 7 meeting signed up for updates directly from Burnham-Ward Properties. Their website is www.burnham-ward.com and everyone is encouraged to check them out. Many residents will now turn to the City of Tustin and attend the November 19 City Council Meeting. Look for any updates in next month's TARWF newsletter!

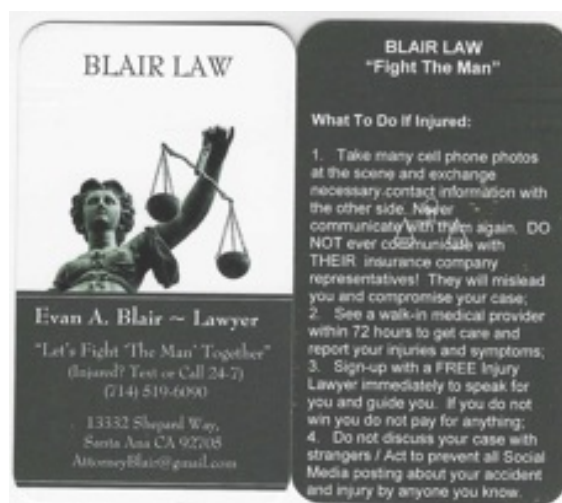
