Program Report



I have been impressed by our new Orange County Registrar over the last few months.

A few of you may know that I had to move quite suddenly in July after the condo I was living in in Irvine was flooded. Testing the USPS mail forwarding system has been quite interesting. Some entities and certain credit cards seemed to know even before the moving truck pulled away, but still much of my mail (especially the important stuff like my car title that I know for sure I changed the

address on) was still being delivered to an empty torn up condo. Within a few days of the move and me filing the mail forwarding order, there was a piece of mail at the old address that really peaked my curiosity. It was a partially filled out voter registration form addressed to 'Resident' that looked nothing like the official forms that we used to use to register folks at public events. In the fine print at the bottom indicated it was printed by the Democratic party of Orange County! How did they know that the registered Republican had moved so quickly? I have a few guesses....

The USPS change of address form that I filed online, gave me the option multiple times to register to vote. There was no option to state I was already registered, just a rebuttal to my refusal on the importance of registering to vote and voting. The USPS had multiple ad's on that website, those retailers promptly bombarding me with ads and offers and discounts on things one might need in a new home. I guess I'm ok with the local Ralphs and Wayfair having my new address, I've done business with them before. What really bothers me is the USPS getting in the voter registration business. I had a gut feeling not to trust the mail for our ballots and registration forms. As much or more so than the DMV, I mistrust their handling of that information.

So, why have I been impressed with our Registrar? Within a few weeks of the move I received a postcard from the Registrar stating that election materials would be coming soon. Then I received another postcard with a portion to return confirming my correct name and address. And yet another postcard confirming all of my information, including my correct party affiliation. Three touch points of confirmation, I thought that was pretty impressive. You should have received your ballot by the time that you are reading this. If you have not received your ballot, please contact the Orange County Registrar right away at OCvote.org.

The OCGOP has asked us to vote early and turn in our ballots as early as possible. This helps direct resources to the lower propensity voters to urge them to get out to vote. I know many of you still would like to vote in person and I'm with you, I don't necessarily like the new system either. But it is the one we've been dealt and we need to start fighting back smarter if we want to save our Country. If you don't like the phone calls and text messages encouraging you vote then turn your ballot in early at an early voting location or at the Registrar's office. Then start making those calls yourself to the low propensity voters! You can bring your ballot to our meeting on October 25th, we'll go over any questions on the propositions and take the completed ballots to the Registrar's office together!

Congresswoman Young Kim and the Honorable Dr Steven Choi will be joining us on October 25th, and I'm working on a couple of other surprises. I hope you all can join us on October 25th!

City of Tustin History



Donna Peery, Office Manager of the **Tustin Historical Society** contributes articles for our newsletter regarding Tustin history and Tustin armed forces service personnel.



William I. Ferrey was born in Pittsfield, Massachusetts on 1 October 1868 to bank president Irving D. Ferrey and his wife Caroline Humphries Ferrey. He married Frances Sophia Kennedy in 1909 and they were the parents of two daughters, Caroline and Jean. William was raised in Pittsfield and after high school attended and graduated from the Sheffield Scientific School at Yale University in 1889.

The 1900 Census shows William as a 34-year-old single man, working as a draftsman. In the 1910 Census, he is a newlywed and partner in an engineering factory. By 1920, he is the father of two,























and partner in a wagon workers company.

The family moved to Orange County in 1922 and built their home at 320 Main Street in 1929. A newspaper article in the Santa Ana Register, dated 11 November 1929, describes it as one of the "many fine homes" built during the year. The home is a Monterey Revival style that was built by Ferrey and carpenter Guy Bolard. The walls are 18-24 inches thick. It's been said that Ferrey used materials from a house that had previously been on the site. The sycamore tree at the rear of the house is estimated to be over 200 years old and was here when Columbus Tustin came in 1868.

William Ferrey became a very successful citrus ranch grower and investor, and his wife Frances was a prominent socialite in Tustin. There is an urban rumor that a couple once knocked on the Ferrey's door and when William Ferrey answered, the couple told him they wanted to buy his house. Mr. Ferrey didn't take them seriously and the couple went away. That couple was Edgar and Libby Pankey that would end up buying the house in 1956. We cannot verify this story, but we do know that the Pankey's loved this house!

Both William Ferrey and his wife would pass away within months of each other in 1950. They are buried at Fairhaven Memorial Park in Santa Ana, California.

Luther Dale "Luke" Yopp was the oldest child and only son of John Henry Yopp and Lena Lee Long Yopp. He was born in 1925 in Kansas, staying for only a short time. Luke's father worked on ranches, primarily working with horses. Originally from Texas, the family lived in Kansas (where Luke was born), then to Oklahoma, on to Arkansas (where little sister Delores "Doty" was born 8 years later), then on to California.

The family lived off of Holt Avenue, Santa Ana city boundaries, but Luke's father John listed Tustin as his home by 1942. Luke attended only one year of high school before going to work on the local ranches.

He enlisted into the United States Army on 22 March 1944, in San Pedro, and after training was sent to the European Theater with the 315th Infantry. Although his sister was much younger and was only 12 when Luke was killed, she always shared with her family that Luke was very protective of her. A story shared by Luke's nephew was that his mom remembered going with her mom and dad and taking Luke to the bus station in Santa Ana so he could catch the bus to boot camp. Prior to catching the bus, they all ate at a diner nearby and while there, his mom noticed a handsome bus boy working there, named Tom Nieblas. They were married several years later. The last time Doty Yopp saw her brother was the day she met her future husband.

Luke Yopp was killed in France just a few months after arriving there. He was 19 years old.

He is buried at the American Military Cemetery in Epinal, France.

The rally ended and it was complete chaos trying to get all of those people back on buses, it took hours. Nolan and I agreed it was all worth it!! I am so grateful to have spent the day with Nolan. We will always remember that special day together!!

Sarah O'Neill's Passionate Fight Against Political Corruption

Sarah O'Neill's story is one of unwavering dedication highlighting her successful finance career to a passionate grassroots advocate. Inspired by her family's legacy of service, Sarah became a leading voice for election integrity in Arizona, demonstrating the power of individual action in the fight against political corruption. This article aims to showcase her remarkable journey and inspire others to join the grassroots movement for a better future.

"Growing up, my family lived by this Golden Rule. ... 'Do unto others as you would have them do unto you.'" Matthew 7:12 – Sarah O"Neill

Sarah's grassroots involvement took off in 2010 when she joined a Southern California Republican women's group, TARWF, serving as Treasurer and participating in the Orange County GOP. But it was the 2020 election that sparked a deeper transformation. Having relocated to Arizona, Sarah witnessed what she believed was a blatant example of election fraud in a state she once thought was reliably conservative. This turning point fueled her commitment to becoming a vocal advocate for election integrity and

























transparency.

"We're the railhead of the big steal every day, with every aspect of it, and we take pride in it. I'm adamant. There shouldn't be anybody in the Trump campaign or the RNC in a paid position that does not believe to the marrow of their bones that the 2020 election was stolen. If you don't believe that, to me, you miss the point of where we are and why we're here" – Steve Bannon



Sarah became heavily involved in the "Stop the Steal" movement, attending numerous rallies at the Arizona Capitol and supporting Liz Harris's canvassing efforts to investigate irregularities. At the same time, she discovered new, alternative media sources that would prove critical in her journey, including WarRoom and Real America's Voice (RAV). These outlets not only provided a platform for her views but also connected her with a nationwide community of grassroots patriots fed up with corruption in both major political parties In 2022, Sarah's activism intensified. She immersed herself in local politics, frequently attending hearings at the state capital to speak out on election legislation and policies. She also served as a poll observer during the 2022 primary and general elections. It was during these experiences that Sarah uncovered alarming discrepancies at her voting center, where more physical ballots were processed than voters who checked in. She didn't hesitate to take action, speaking at the Maricopa County Board of Supervisors meeting and raising awareness on platforms like GETTR, Truth Social and even securing a segment with Steve Bannon on WarRoom.



Sarah's commitment extended beyond individual observation. She joined a "Morning Warrior" Zoom meeting, where she strategized daily with 80-100 other activists from across Arizona. Together, they focused on building a grassroots movement aimed at challenging the establishment and placing grassroots leaders in key positions at both the county and state levels. Their efforts paid off with a 90% success rate in electing grassroots convention delegates, a testament to the power of collective action.



Sarah also worked closely with We The People Alliance AZ, supporting legal challenges like Abe Hamadeh's election contest. Her work behind the scenes as part of the Maricopa County Elections team has provided her with invaluable insights into both the positive developments and troubling concerns in the electoral process.

Now deeply awake to the reality of political corruption and the influence of the uniparty, Sarah remains committed to the fight for the future of the country. Her determination is unwavering, fueled by her family's history. Sarah's parents instilled strong Midwestern values and a sense of duty, with her father's Marine service and her mother's resilience shaping her commitment to family and country. Also, it was Sarah's son's near-death experience in Iraq which deepened her resolve, fueling her desires for a safe and prosperous nation for her granddaughters.

Sarah O'Neill's journey into grassroots activism is a reminder that real change begins when we take action. 
