City of Tustin History

The Little Tree Church of Jamestown Village



Claude Thaxton Gilbraith, a builder and developer originally from Columbia, Tennessee, moved to Orange County in 1954 and thought Tustin had great potential to become an elite community. The Galbraith family purchased and moved into the Preble Home (also at one time called the Crawford Home) and lived there until 1960. The George Preble home, built in 1885, sat on two acres of land that included an orange grove and avocado trees, located at 520 El Camino Real. C. T.'s vision was to build a shopping center on the home site. The magnificent Victorian home was offered for free to anyone that would move the home off the lot. The thought of preserving historic homes wasn't a popular thought at the time and since no

one wanted the home, it was demolished when the shopping center was built in 1962.

C. T. kept the large, old oak tree that was at the corner of the barn site and wasn't sure what to do with it, but knew it had to be special. C.T. thought about the time that he used to drive his grandmother, in horse and buggy, to church in Tennessee and decided to build a replica of the Antebellum church that she attended. The miniature church is 16 feet tall and at the time it was built, the 40-foot oak tree was right through the center of it! It seats 8 people and has an organ in it. The oak tree eventually was removed, due to disease, but the "little tree church" remains in the Jamestown Village Shopping Center and is still owned by the Galbraith family.



Paul Carroll Kimball Jr
Second Lieutenant

United States Army
1st Fighter Group, 71st Fighter Squadron
Born 03 October 1921
Killed in Action 14 August 1944
Italy

Paul Carrol Kimball Jr. was born 03 October 1921 in Grayson, Texas the oldest and only son of Paul Carroll Kimball and Ida Alberta Box. He was a premature baby and very tiny at birth. The family moved to Orange County in 1924, when Paul Jr was three years old. His little sister, Dorothy was born when Paul was seven. His little sister called him "Bub", a nickname that stuck with the rest of the family calling him that from that point on. Mr. Kimball was a World War I Army veteran and employed by the Tustin Lumber Company as a Mill Worker. The family made their home on Mountain View Street, not far from Mr. Kimball's work. Paul and his sister Dorothy attended Tustin elementary and Tustin High School.

Paul was a smart student, well liked and active in school. He was a member of the Broadcaster staff and vice president of the Candid Camera Cutup Club. After graduating from Tustin in 1939, Paul continued his studies at the University of California Berkley, majoring in Mechanical Engineering.


On January 5, 1943, Paul entered the Army Air Force and received training at the Santa Ana Army base, Dos Palos Eagle field, Le Moore field and Luke field in Arizona. The family was told that Paul was a "hot shot" and rumor has it he flew his plane under the Golden Gate Bridge.

His niece, Shelley Weir, said Paul was close to his family and wrote letters home all the time.

Second Lieutenant Kimball was sent to the Italian theater on July 10, 1944 as a P-38 pilot with the 1st Fighter group of the 71st Fighter Squadron. Within weeks of arriving, Lt. Kimball was shot down and died from his wounds eight days later. He was 23 years

old.

He was awarded the Presidential Unit Citation and two Purple Hearts. He is buried at Fairhaven Cemetery in Santa Ana next to his parents and sister.
