Cancellation Policy: No refund requests will be issued after the pre-entry closing date of September 26th, 2024. No refunds will be issued for absent, excused, or disqualified dogs. **No entry shall be accepted from a dog or handler disqualified from the ASCA Conformation program or from a person not in good standing with ASCA.

Classes: Run Order - Juniors, Puppies, Altered, Intact

Junior Classes: Novice & Open, to be divided by ages: 8-12 years & 13-17 years. NOTE: Juniors may compete with any breed; however for ASCA points in the merit programs, the dog must be an Australian Shepherd and must meet ASCA Junior ownership requirements (rule book available at www.asca.org)

Conformation Classes: (to be divided by sex):

Show Venue:

Hours: The show site opens at 7 am Sat., October 5th and closes at 7 pm Sat., October 5th. Grounds must be vacated by 7:15 p.m.

Environment: Grassy area in an unfenced public park. Restrooms, nearby parking, covered pavilion areas are available, canopy/set up areas near show ring. Canopy stakes may be no longer than 10 inches. There is no power available on-site, but generators may be used. No food vendors will be available on-site. Food vendors are within 10-15 mins driving distance. River is nearby, with no lifeguard on-site. Please keep children under close supervision.

Day Parking: Parking lot is adjacent to show site.

RV parking (overnight stays): can be arranged through Snohomish County Parks. Yurts are available (no dogs allowed in yurts). https://snohomishcountywa.gov/Facilities/Facility/Details/River-Meadows-Park-46


Directions to show grounds:
