Prices are subject to review with at least 60 days' notice provided to the Owner.

#### **6. Notice Period**

Either party may terminate this agreement by giving one full calendar month's notice in writing.

#### **7. Veterinary & Emergency Care**

Highhurst Stud reserves the right to contact a qualified veterinarian at the Owner's expense if the horse requires medical attention or is deemed to be in distress.

Every effort will be made to contact the Owner in advance, but in the case of an emergency, the Yard's decision will be final in the interest of the horse's welfare.

#### **8. Insurance & Liability**

The Owner is responsible for insuring their horse against veterinary fees, public liability, and personal accident.

The Yard does not accept responsibility for injury, illness, theft, or loss unless caused by proven negligence.

#### **9. Horse Welfare & Conduct**

The Owner agrees that the horse is up to date with vaccinations, worming, and farriery.

The Yard reserves the right to ask the Owner to remove a horse that is dangerous, disruptive, or unfit for livery.

## 10. General Conditions

The Owner must abide by all current yard rules and policies.

Any changes to this agreement must be made in writing and signed by both parties.
