All cancellations must be made in writing and are valid per postmark and must be received in the San Antonio office at PO Box 461368, San Antonio, Texas 78246. While verbal communications are appreciated, they do not replace the legal requirement to cancel in writing!

In the event that you are unable to attend your tour, you may sell your package to someone else. Once you have arranged for them to attend in your place, any financial exchange is up to you and there are name changes fees that will be passed on from vendors. You will remain responsible for the completion of your payment plan and for payment of any additional penalties or fees.
