Legal Disclaimer

These are the terms and conditions that apply to the educational transformation services offered through **Obsidian Opulence**, operated by **Alana McClure** (may also be referred to as "Alana McClure," "the Educator," "the Practitioner," "Affiliate," "Service Provider," "I," "me," or "my"). These terms and conditions are to be read together with any service agreement and any other written agreements between us. These documents together form our entire agreement.

Please read these terms and conditions carefully, as they outline the rights and responsibilities of both the Service Provider and the client. By engaging in educational or experiential services, you agree to be bound by these terms and conditions.

1. Therapeutic Educational Services

- **1.1.** Therapeutic educational services, also known as **Advanced Transformational Healing**, offered through **Obsidian Opulence** are focused on addressing personal, emotional, psychological, and physical challenges while offering knowledge and tools for future life transformation practices. These services may be delivered online, in person, via telephone, or a combination of all three. Unless expressly agreed upon otherwise, online services are offered via Zoom or other secure video conferencing platforms.
- **1.2.** The approximate duration outlined on service offers is an estimate based on the needs of an average client. You will receive an approximate number of hours of educational or experiential sessions as defined in your service offer, based on your individual needs at the time of each session. Hours may be reallocated to other dates/times as deemed appropriate by your personal protocol.
- 1.3. Obsidian Opulence and Alana McClure offer educational and experiential immersions to assist with psychological, emotional, physical, and transgenerational challenges. Unless explicitly stated otherwise, these services are not provided by a licensed medical doctor or psychologist. Educational experiences are offered within specific areas of expertise and do not include diagnoses, prescriptions, or support outside of the scope of practice. Terms such as "counseling," "therapy," and "coaching" are used collectively as education and experience, focusing on understanding, resolving, and healing emotional trauma carried from the past and integrating that healing into the present and future. These experiences are designed to help you understand shadows of the human psyche and ancestral or epigenetic trauma, while redirecting attention toward personal goals, strengths, and aligned action.
- **1.4.** Educational and experiential services are intended to support your overall quality of life and deepen your connection to Self and to Consciousness. Outcomes are not guaranteed, as true healing occurs from within and cannot be directed by any outside coach, therapist, educator, teacher, or healer.

2. Services

- **2.1. Obsidian Opulence** offers 1:1 and group experiences either online, in person, or via phone. In-person service fees do not include travel, accommodations, or meals unless otherwise specified in writing.
- **2.2.** Online and in-person sessions are subject to the availability of the educator. It is the client's responsibility to request session times that suit their schedule. Booking is handled through direct communication with **Alana McClure** or an authorized team member. A request for a specific date/time does not guarantee availability, although all reasonable efforts will be made to accommodate you. Emergency sessions may be arranged on an as-needed basis for clients in crisis (e.g., terminal illness, risk of self-harm, etc.).
- **2.3.** Advanced Transformational Healing unfolds in its own organic rhythm—not necessarily in a logical or linear timeline. In honoring this natural flow, you agree to flexibility in your service protocol and scheduling. Booked sessions are subject to change. Any unused sessions on the part of the client are valid for six (6) months from the date of last use or initial booking, whichever is later. If **Alana McClure** reschedules a session, it will be offered within four (4) weeks of cancellation, at a mutually convenient time.
- **2.4.** Rescheduling of private 1:1 online sessions requires at least forty-eight (48) hours' notice. Please contact **Alana McClure** directly to reschedule. If you are unable to attend a scheduled group session, you will be given access to a recording and any applicable follow-up materials.
- **2.5.** The terms for 1:1 educational or therapeutic services are as follows:
- Private single or multi-session packages must be used within six (6) months of purchase.
- If your personal circumstances shift dynamically, and it is mutually agreed that extending your timeline is in your best interest, alternate arrangements may be made through direct communication with **Alana McClure**.

3. Client Responsibilities

- **3.1** As a client of **Obsidian Opulence**, you acknowledge and agree to the following:
- (a) You are solely responsible for scheduling your private educational, therapeutic, or experiential sessions.
- **(b)** Your transformational experience with **Obsidian Opulence** is a co-creative process. You understand that your progress and results are your own responsibility and are influenced by your level of engagement and willingness to evolve.
- **(c)** You agree to actively participate in the transformational journey, including but not limited to completing practices, self-reflection, and providing relevant information to support the work. You understand that Advanced Transformational Healing intentionally

moves stagnant emotional, mental, and psychological energy, which may result in temporary discomfort. This is a natural part of the process. You accept that this discomfort is not harm but rather a sign that outdated belief patterns and constrictive emotional landscapes are being disrupted.

- (d) You are responsible for communicating any arising feelings—such as fear, grief, rage, confusion, or sadness—with your educator or therapist. You acknowledge that these shadow expressions are expected within this work and are not personal in nature. The transformational container is sacred and safe for such emotional disclosures and is built on mutual trust and transparency. It is understood that your educator's role is to guide—not to cause—these reactions, and that all guidance is offered in service to your healing.
- **(e)** You are the ultimate steward of your physical, emotional, and mental wellbeing. Your sovereignty includes discerning and honoring your own boundaries and communicating openly about your thresholds. While **Obsidian Opulence**programs may activate recalibration through somatic, neurological, and energetic shifts, participation is voluntary. You may discontinue your participation at any time, though such withdrawal does not entitle you to a refund for any unused portion of services or programs.
- **(f)** If you are currently under psychiatric care, using pharmaceutical medications (including but not limited to birth control or hormone therapy), you are required to disclose your participation in **Obsidian Opulence** offerings to your primary healthcare provider. You are responsible for determining with their guidance whether these services are appropriate for your current mental and physical condition.

4. Fees and Payment

- **4.1** You agree to pay all program or service fees as outlined at the time of purchase, on the official service agreement, or as discussed and confirmed directly with **Alana McClure** or her team.
- **4.2** Payment may be made via credit card, debit card, WISE, bank transfer, or any other method accepted by **Obsidian Opulence**. Full payment instructions will be provided upon request or at the point of engagement.
- **4.3** Failure to make timely payments may result in the suspension or termination of services. In the case of apprenticeship programs, failure to submit payment for two (2) consecutive months may result in suspension of your apprentice status.
- **4.4** All fees paid are non-refundable unless explicitly stated in writing in the service agreement. In specific cases, some fees may be transferable to another program or offering at the discretion of **Alana McClure** and must be agreed upon in writing.

5. Refund Policy

5.1 The intention of **Obsidian Opulence** and its affiliated educators, facilitators, and service providers is to deliver highly personalized transformational experiences that

support emotional, psychological, somatic, and behavioral recalibration. While group programs may be less customized than 1:1 work, your individual needs will always be held with care, and additional support may be arranged upon request. By accepting a place in any **Obsidian Opulence** offering, you acknowledge that limited space and significant time and energetic resources are devoted to your presence. Therefore, if you voluntarily withdraw from a program or service prior to its completion, **no refunds will be issued**.

- **5.2** Refunds will not be granted under any of the following conditions (this list is not exhaustive):
- **(a)** You are unable to attend all scheduled sessions within the specified timeframe.
- **(b)** You are unable to schedule sessions at a specific date or time.
- **(c)** You are unable to book your sessions within your preferred timeframe.
- **(d)** You miss sessions or fail to attend due to personal issues (including illness, family obligations, travel disruptions, etc.).
- **(e)** You experience emotional discomfort, activation, or resistance during the process, or have friction with your chosen Educator/Therapist/Facilitator. These responses are natural components of transformational work and do not constitute grounds for a refund.
- **5.3** In certain cases, at the sole discretion of **Alana McClure** or her designated service providers, **partial refunds in the form of a transfer of unused funds** may be considered. These options may include:
- (a) Transferring your balance to another **Obsidian Opulence** service or offering.
- **(b)** Deferring your balance to a future date or cohort.
- **(c)** Transferring your balance to another approved client or participant, where mutually agreed upon.

Please note: While all reasonable efforts will be made in good faith to accommodate your circumstances, **there is no guarantee** that all requests can or will be fulfilled. If you require specific accommodations, these must be discussed with your Educator/Therapist prior to committing to a program or service.

6. Termination

- **6.1** Services, programs, or containers will conclude at the end of the agreed-upon term as outlined in your initial service agreement or program details.
- **6.2** In the rare event that **Alana McClure** or an affiliated educator is no longer able to deliver the services agreed upon (due to circumstances beyond their control and not due to client absenteeism), this agreement may be **terminated with written notice**, at which point a **pro-rated refund** may be issued based on services already delivered or remaining, at the discretion of **Obsidian Opulence**.

7. Confidentiality
