As Christmas approaches once again, so, too, does my son's birthday. I marvel that it has been 18 years since Christmas changed for me forever. I will never again celebrate just Christmas, but I will celebrate Christmas and birthday, the birth of Christ and the birth of Owen, all in the same week. A busy time became even busier. A merry time became even more merry. An expensive time became much more so. One thing that comes with Christmas that never changed and never will change, however, is the hope that comes with the belief that God is born and is with us.

I need that hope now more than ever, and I imagine you do as well. Christ comes not for celebrations and parties, not for fun and games, not for TV specials and store sales, but so that each person may know his or her true worth. Our value is not measured by how many presents we get and neither is our spirit judged by how many presents we give. Secretary Minutes

November 12, 2025

We Assemble in God's Name

Moderator Gary Ford called the meeting to order at 6:59pm. He opened the meeting with a devotion, prayer and lighting of the Christ Candle.

We Celebrate our Past

The FMCC Board reviewed the submitted reports from the Senior Minister, Associate Pastor, Board Secretary, Treasurer and Church Clerk.

Moderator Gary Ford asked if there were any questions regarding these reports or if there were any comments from the person submitting these reports.

Jerry Puskarich suggested a couple corrections. On page 2 of the Senior Minister's report, the word "add" should be "ad." On page 4 of the Associate Pastor's report, the word "continue" should be "continues."

Brian Shaw noted that the \$4,300 deficit showing in the Roof Fund will be offset with funds from the Fawcett Fund through the Trustees' checking account.

A motion to accept these reports was made by Ed Palfreyman and seconded by Linda Reese. The motion was carried unanimously.

We Present Our Offering

The FMCC Board reviewed the submitted Ministry Reports. Reports were received from the Elders, Trustees, Stewardship/Finance Ministry, and Personnel Committee.

Moderator Gary Ford asked if there were any questions regarding these reports or if there were any comments from the person submitting these reports.

Jerry Puskarich presented additional notes to the Stewardship/Finance Report verbally (see attached Jerry's written report).

Serena Dube noted that members of the Personnel Committee, Trustees, and the Pastors met today with Claudia Montoya Lopez for the 30-day review of her work as our new Custodian. Claudia is doing well.

Serena also added that the Operating Deficit Task Force would like to establish itself as a permanent "Ministry" rather than continue as a Special/Standing Committee. Jerry Puskarich suggested that the name of the new Ministry be "Gathering to Grow." Rev. Chris questioned why the Task Force could not continue under the name of the Evangelism/Outreach Ministry or the Fellowship Ministry since that is the nature of the work they are doing. This will be discussed further at the January Board meeting.

A motion to accept the Ministry Reports was made by Peggy Oliverio and seconded by Carmen Oliverio. The motion was carried unanimously.

Concerns of the Past (Old Business)

No old business was brought forth.

Issues of the Future (New Business)

1. Calling Commission nominations for 2026 Church Officers

The Calling Commission submitted its nominations for Church Officers in 2026. Moderator Gary asked that Candy Wasalasky be added to the list as Secretary, as she has agreed to serve in that capacity.

Linda Reese made the motion to recommend the slate of nominated 2026 Officers to the congregation. Jerry Puskarich provided the second. During discussion of the motion, Gene Sheller noted that the Moderator can nominate someone at any time to serve on the Personnel Committee, should someone be willing to serve. A vacancy in any Office can be filled by nomination of the Moderator in consultation with the Pastors and election by the Board. The motion was carried unanimously.

2. Salting/Plowing the church parking lot

Trustee Ed Palfreyman told the board that Shane Fowler cannot do the salting and plowing of the church parking lot this winter due to his upcoming surgery. The Trustees are actively seeking bids for doing the salting and plowing and will welcome any contacts. Kevin Puskarich suggested that only part of the lot could be plowed during the week to help save on salt and snow removal costs.

3. Proposed Budget for 2026

Treasurer Brian Shaw highlighted that there is a 2.7% increase for staff. A full or partial increase can be given based on performance. We have saved \$3600 by switching to Verizon for internet and phones. Key costs to consider for next year will be increases in the plowing/salting, electricity and gas bills. The new janitor will receive the same hourly rate as the former, but she will be working fewer hours (20 instead of 25).

The motion to recommend the 2026 budget to the congregation was made by Kevin Puskarich with a second by Ed Palfreyman. During discussion, Serena Dube asked if it's time to retire the church van. Jerry Puskarich said we can't justify the cost of keeping it, and getting rid of it would open up more room in the garage. Trustees will see what they could get if they sold the van. Will discuss further. The motion was carried unanimously.

4. Outside groups interested in using the church facility and grounds

a. Dalton Harps – Car Cruise

Rev. Chris received a request from Dalton Harps of Rick's Auto to use the church parking lot for car shows on Sunday afternoons from May through September. Discussion followed. Jamie Hatfield knows from experience that selling food at car shows can be quite profitable. Carmen Oliverio made a motion to permit the use of the parking lot for car shows. Jamie Hatfield seconded the motion. The motion was carried unanimously.

b. Soccer Shots – Large Fellowship Hall

Rev. Chris received a request from a group called "Soccer Shots" to use the large hall on Saturdays in January and February from 9-1:30. Discussion followed. Chuck Riggle made a motion to let Soccer Shots use the large hall and Kevin Puskarich provided the second. The motion was carried unanimously.

Other Discussion

Von Lacock said that the church has received a check from the Literacy Council (a grant from EQT) for \$25,000 to air condition the Large Fellowship Hall.

Chuck Riggle said 50 people attended the Notes of Thanks concert and \$827 was raised.

Connie Sheller stated animals are needed for the Drive-Thru Nativity.

There is a Congregational Meeting scheduled for November 23, 2025 following worship.

Leaving in God's Name

Carmen Oliverio motioned to adjourn the meeting with a second by Ed Palfreyman. The motion was carried unanimously.
