The FMCC Board reviewed the submitted reports from the Senior Minister, Associate Pastor, Board Secretary, Treasurer (from the Financial Secretary), and Church Clerk.

A motion to accept these reports was made by Craig Dotson and 2nd by Connie Sheller. The motion carried.

We present our Offerings

The FMCC Board reviewed the submitted Ministry Reports. Reports submitted were from The Pastor's Cabinet, Elders, Deacons, Trustees, Stewardship/Finance Ministry, Evangelism/Outreach Ministry, Personnel Committee, and Disciples Women's Ministries.

A motion to accept the Ministry Reports was made by Linda Reese and 2nd by Jerry Puskarich. The motion carried.

Concerns of the Past

There were no concerns of the past.

Issues of the Future

1. Presentation of 2022 Church Officers

The incomplete list of the 2022 Church Officers was presented to the Board. The Elders list consists of only 7 members. The Calling Commission has exhausted the membership list while trying to find 2 additional Elders. Associate Pastor Gena Sheller noted that this was a concern with only 7 Elders and the share of the church members which these Elders must mentor. There will also be extra Sundays which the Elders must serve at the communion table.

The Board of Trustees is also in need of 1 person.

As for the absence of Financial/Secretary officers, Assoc Pastor Gena Sheller said that they may not be needed, as there is no counting of the offering due to Covid.

A motion to present the 2022 Church Officers to the congregation as is, was made by Serena Dube and 2nd by Diane Palfreyman. The motion carried.

2. Proposed 2022 Budget

Jerry Puskarich of the Stewardship/Finance Ministry, talked about The Factor Analysis Sheet which he prepared for the 2022 Budget.

A motion to present the Proposed 2022 Budget to the Congregation was made by Ed Palfreyman and 2nd by Craig Dotson. The motion carried.

3. FMCC Vacation and Sick Day Policy

Jerry Puskarich, Chairperson of the Personnel Committee reviewed the new Vacation and Sick Day Policy with the Board. Since the choir director is off during the summer, it was noted that he should only have 3 Sundays off per year. Also, it was suggested that holidays which are on a weekend, should give the option of taking Friday or Monday off. The choir director and organist should not take 4 Sundays off in a row, including choir practices during that week.

This policy takes effect in 2022. It begins from the date of hire.

Motion to accept the FMCC Vacation and Sick Day Policy with the above changes was made by Connie Sheller and 2nd by Carmen Oliverio. The motion carried.
