With that in mind, I give thanks that Sunday School has returned, and I am grateful for Pastor Gena's leadership and the work of our teachers. The church picnic was a joy. I am grateful for the return of our Deacons serving communion in worship and the efforts being made to resume our choir. In particular, I am excited that we have a membership class and can look forward to baptisms come November. There is also plans for something new, a "Trunk or Treat" event, which you can read more about in this newsletter.

All of this is happening even as we begin our time of stewardship emphasis and while the calling commission is looking to finalize its slate of officers for the coming year. I don't think any of us are comfortable with how things are at the moment, but I hope you will not wait until you are completely comfortable to be involved in the work of the church as comfort is the enemy of progress. Let us take this time to do what we can with what we have and what we have is this moment and this church. Let us make the most of both, together.

Dear Fairhill Family,

Soon you may be contacted by a member of this year's Calling Commission, a group of Elders, Deacons, and several members of the congregation at large, whose responsibility it is to prayerfully consider who in our congregation might have the gifts and skills needed to serve in 2022 as Officers (Moderator, Vice Moderator, Congregational Secretary, Elder, Deacon, Trustee, Church Clerk, Assistant Financial Secretaries, and Church Historian).

What should you do if you are called upon to consider serving in one of these ways?

1. Keep breathing. Thank God for the opportunity to ponder how you are a part of the ministry of Fairhill Manor Christian Church. Ask God to guide your discernment.

2. Ask questions. What specific tasks will you be expected to do in this role? What responsibilities will you have? How much time should you plan to set aside to serve well? (Please do not believe anyone who tells you "don't worry; there's not much to do in this role." If the role weren't important, we certainly wouldn't be asking you to consider serving in it!)

3. Ask for the name of someone who has served in this position recently and talk with that person about his or her experiences.

4. Spend time thinking about your own gifts and skills. What type of work have you done? What hobbies do you have? What gives you energy and enjoyment? What really frustrates you about the church (i.e., about what do you say, 'If it were me, I would do ... differently')? Just as we are told not to leave our faith at the door on the way out of church, so we also are not to check our abilities and skills at the door on the way into church. Bring who you are – all of your experiences and talents – and offer them in service to the church!

"Your vocation in life is where your greatest joy meets the world's greatest need." ~ Frederick Buechner, a Presbyterian minister, author and theologian

5. Ask God; is this what you have for me to do in this time and in this place? I believe that God gifts our congregation with just what we need for the work to which God is calling us. So, the work of the Calling Commission is really that of a matchmaker – matching the work which is to be done with those who have the gifts, experience and energy to do it.

Please, please do not serve out of guilt. But please do not refuse to serve out of fear.

6. If you decide that this is the work to which God is calling you this year, give the Calling Commission the good news. If you decide that you aren't a good fit for the role, ask your Pastors how a person with your gifts, interests and experiences might serve. Maybe a new ministry is just waiting to break forth. But whatever you do, don't miss the opportunity to serve! Your faith will grow, deepen and bring you more and more joy as you put it into action!

Fairhill Manor Christian Church Board Meeting Secretary Report September 8, 2021

We assemble in God's name

Moderator J.C. Leasure called the meeting to order at 7:06 PM with the lighting of the Christ Candle. J.C. opened with prayer.

We celebrate our past

The FMCC Board reviewed the submitted reports from the Senior Minister, Associate Pastor, Board Secretary, Treasurer (from the Financial Secretary), and Church Clerk.

A motion to accept these reports was made by Jerry Puskarich and 2nd by Von Lacock. The motion carried.

We present our Offerings

The FMCC Board reviewed the submitted Ministry Reports. Reports submitted were from The Pastor's Cabinet, Elders, Deacons, Trustees, Stewardship/Finance Ministry, Evangelism/Outreach Ministry, Personnel Committee, Disciples Women's Ministries, Disciples Men's Ministries and FMCC Croppers.

Linda Reese noted that the Evangelism/Outreach Report should include the addition of 24 units of food brought to the First Church of the Nazarene by Donna Stemski on August 28th.

A motion to accept the Ministry Reports was made by John Anderson and 2nd by Ed Palfreyman. The motion carried.

Concerns of the Past

The Pastor's Cabinet presented the following updated and improved Covid Protocol recommendations to the General Board for approval.

"The main objective of the Cabinet throughout this pandemic has been the safety of everyone who enters the church. Continuing with that goal, the Pastor's Cabinet makes the following recommendations to the General Board for its acceptance and approval.

1. These revised protocols will become effective upon Board approval.

2. Entrance and exit from the church will be by the rear door.

3. Masks will continue to be required by everyone entering the church. This is to protect the children, who cannot yet be vaccinated, as well as other vulnerable groups.

4. Beginning Sunday, September 12th, the church will return to the practice of four deacons collecting the offering from the congregation in the pews. Additionally, communion cups will continue to be offered but communion trays will be passed, as in the past, to the congregation by the deacons. A small table, with bulletins, will be at the entrance to the Narthex.

5. Commencing Sunday, September 12th, two elders will return to present the bread and cup. After the blessing, the elders will provide the communion plates to the deacons for distribution. The elder serving the bread will have the prayer at the table. The elder serving the cup will be responsible for registering attendance of all who come for worship.

6. Everyone entering the church building is required to wear a mask and sign in on the sheet available on the bulletin board. At Sunday worship, attendance will be registered by an elder.

7. We will continue to social distance by leaving every other pew empty. The red yarn previously used will be removed and the pew cushion, in an up position, will indicate the pew is to remain empty. Guides will continue to seat everyone entering the Sanctuary and will also excuse worshippers, by row, at the end of the service.

8. We will continue to enjoy worship music without congregational singing. We hope that congregational singing and the choir will be added back to worship during the Fall.

9. Children may go to the front of the Sanctuary for the Children's Message. Children Worship & Wonder is now available and participating children will leave by the side door.

10. Water fountains will remain closed.

11. Outside groups will be permitted to use the church, under the same conditions as set forth above (including entry/exit, wearing masks, signing in, and social distancing in the Sanctuary). Weddings shall not be permitted yet; however, memorial services requested by members of the congregation will be permitted. Upon request for the Sanctuary to be utilized for a memorial service, the funeral director or whomever is making the request will be informed of the required protocols.

12. The Literacy Council has restarted its classes. All participants must be vaccinated, masks must be worn at all times, except when one on one tutoring is taking place, and class sizes have been reduced. The Council currently utilizes two rooms as offices and three rooms for tutoring. If additional space is required a request must be made through the church secretary.

13. Zoom services will continue for worship and meetings if desired.

A motion to accept this revised Covid Protocol was made by Linda Reese and 2nd by Connie Sheller. The motion carried.

Issues of the Future

1. The list of 2021 Calling Commission Members was presented to the Board by Moderator, JC Leasure.

2021 Calling Commission Members

"A calling commission of four elders, three deacons, and two members of the congregation, who are not members of the general board, shall be appointed by the moderator, approved by the board, and announced to the congregation at least eight weeks prior to the annual congregational meeting to nominate candidates for office of the congregation." – Section D Article, 1 Constitution & Bylaws

2. Rev Chris Stillwell spoke concerning an outside small group of woodworking guys needing a weekly meeting place. Ed Palfreyman will meet with them to discuss this further.

3. The trustees spoke about the work and cost of a project to eliminate water which has been coming in the basement at the front of church. Piping will be replaced and tied into the downspouts. concrete will be redone. Rhododendron and tree roots are pushing on the wall of the church. These will be removed. The cost of this project is \$6580. Jerry Puskarich reminded the trustees that the company would need to fill out the W-9 tax form. A motion to accept the bid of this project was made by Linda Reese and 2nd by Peggy Oliverio. The motion carried.

4. Senior Minister Chris Stillwell emailed the attending board members on Sep 9, 2021 about an important item which he forgot at the meeting. Rev Thad Allen, our regional minister, is available on Sunday, November 7 for his installation. Sometimes that involves a separate service in the afternoon, but Rev Chris does not think that would be necessary. He was thinking that Rev Allen would take part in our regular service and would lead the act of installation as part of that service.
