Color the image, and email it to Morgan's Magical Media, at: sales@morgansmagical.com before January 31, 2025. Any entries received after January 31, 2025, will not be eligible.

HOW TO ENTER. NO PURCHASE NECESSARY. Entrants submit a coloring book picture from our web address: <https://morgansmagical.com/coloring-contest>. Only official illustrations from the Morgan's Magical Media web address are eligible for entry. Entrants may only enter the contest once.

ELIGIBILITY. This contest is open to all children from 4 to 10 years of age.
