### Greetings Art and craft vendors,

Thank you for your interest in participating as a vendor in the 3rd. Annual 1/2 to St. Patrick's Day Irish festival. This is a one-day rain or shine event. Please read the following stipulations carefully. This form must be signed and returned with your vendor application, liability form and payment must be received by Friday, July 20, 2024 for consideration.

# Vendor eligibility

The Friendly Sons of the Shillelagh, Carolina chapter and the (Beaver Bar) staff reserve the right to determine whether any vendor product or display is eligible for inclusion in this festival. no drugs or drug paraphernalia no explosion items, fireworks aerosol, propelled items, or lighters no stink bombs or anything similar that require the production of ignition no knives swords, guns, or any type of weapons.

## **Vendor space rental**

10' x 10' spaces are pre-determined dimensions at which the exhibitors agree to stay with them. The exhibit may not exceed in front of any adjacent booth or exhibit and must stay within the dimensions of the 10' x 10' deep space given. If additional space is required. You must purchase additional 10' x 10' spaces benders not are not allowed to sit or place merchandise/equipment on the side. Vendors and their representatives must stay within the both spaces during the festival; they are not allowed to leave their space till to sell items except donations, distribute liberty or literature/coupons, etc. Vendors must also keep their booths in line with the other vendor booths to ensure proper flow.

# Set up & Breakdown.

Vendor set up will begin at 8:00 AM. You must check in by 8:30 AM or you will not be allowed to drive into the festival area. Vehicles must be out of the festival area by 9 AM. After unloading your equipment, park your vehicle in a public parking area and return your booth to set up. No vehicles may remain on the property. The festival map and parking information will be included in your vendor pack vendors must be set up no later than 9 AM. You will be responsible for all your booths set up, tear down, supplies, tables, workers, etc. Vendors must furnish their own tents, tables, equipment, and signage. Tents must be weighted to withstand gusts of 60 mph winds. Tent stakes are not allowed.

All vendors must check in at the corner of Carson Ave. and 17 business. There will be a check in sign on the corner.

Breakdown begins at 5 PM, no earlier vehicle traffic will be allowed to go into the festival area at around 5:15 PM, depending on pedestrian traffic determined by the festival committee or by the Beaver Bar staff.

### **Vendor Limitations**

- 1. Vendors and their representatives must stay within their booth space during the festival; they are not allowed to leave their space to sell items.
- 2. Only vendors that deal specifically with animals or service dogs are allow in their booths. If you sell pet supplies, pet costumes, etc. this does not qualify.
- 3. Electricity is not available. Vendors are not permitted to directly wire disconnect any electric service.
- 4. No festival generators are not permitted unless preapproved by the (Beaver Bar) and the FSOS Committee staff.
- 5. Vendors are expected to leave their area free of trash and waste and placed in the designated trash containers.
- 6. We do try to honor special request, but not always able to accommodate them
- 7. Arts & Craft vendors are not allowed to give away or sell beverages/food. Only Food vendors are allowed to sell beverages/food.
- 8. Tents Stake are not permitted.
- 9. NO REFUNDS- Once accepted Festival is held rain or shine
- 10. Vendors may not sublease their space, nor any part thereof.
- 11. The vendor acknowledgment agreement that or her exhibits should be admitted, and shall be permanent to remain in the festival ground upon continuing strict compliance with the vendor, and the terms and conditions of the agreement, not withholding such compliance, the friendly sons of the reserve, the right to reject the removal, vendors exhibit in Hall, or in part for the festival ground for any reason whatsoever no portion of the rental shall be returned. If the rejection removal occurs a part of violation of this agreement.

### Waiver

All vendors must sign and submit a copy of the liability form along with their payment and application. Vendors agree to indemnify defend and hold harmless the Friendly Sons of the Shillelagh and its officers and staff as well as the owner of the (Beaver Bar) and their staff against any, and all third-party claims and other liabilities that are caused by, arise from, or grow out of the negligent acts or omissions of the vender, its agent, officers, employees, representatives, servants, invitees, patrons or guests.

# **Security and liability**

We have 24-hour security during the festival however we cannot guarantee your individual items. By acceptance of this agreement, the vendor expressly releases the FSOS and the Beaver Bar employee's officers and the lessors/owner of the exhibit equipment of any or all liability for loss, theft, damage or destruction of property; nor for any injury to vendors or its employees while in festival grounds.
