



## 2019 Scholarship Application Process

Thank you for your interest in applying for the Pennsylvania Saddlebred Horse Association scholarship and particularly for your commitment to the Saddlebred horses and equestrian sport.

This scholarship is specifically for youth 17 years of age and under who are PSHA members in good standing. The scholarship money awarded will be a one-time scholarship which is non-transferrable and all funding will be paid directly to the camp or clinic.

The scholarship application period for 2019 opens on February 18, 2019. It will close at the end of the business day on March 22, 2019. All completed applications must be postmarked by March 22, 2019. Please submit all paperwork to: **Mary Beth Charon, 8517 Gateway Road, Breinigsville, Pennsylvania 18031.** ***Applications that are incomplete, will not be reviewed.***

## **FREQUENTLY ASKED QUESTIONS:**

**Am I eligible to apply for a scholarship?**

**Scholarships are awarded to any PSHA youth 17 years of age and under in good standing with the PSHA.**

**How is the scholarship money distributed?**

**Checks are not made payable to the individual. All checks will be made payable to the clinic or camp you chose on your application.**

**What types of camps or clinics will PSHA consider funding?**

**Applicants may request scholarship money for any camp or clinic that is horse related that will further their equine education, or riding skills.**

**How much funding does PSHA generally award?**

**PSHA will award up to \$150.00 for the winner(s) of the Camp/Clinic Scholarship. PSHA reserves the right to award as many or as few scholarships as deemed appropriate based upon the scholarship requests received.**

**When can I expect to learn if I will receive a scholarship?**

**The scholarship review committee meets to consider all scholarship applications during the same month as the deadline and expects to announce its decisions in the following month. However, PSHA reserves the right to alter the timeline. All applicants, including those not chosen, will be notified of the board's decision in writing.**

# Terms and Conditions

- 1. PSHA reserves the right to use any materials provided as part of the application process for promotional purposes.**
- 2. Applicant agrees to acknowledge PSHA scholarship funding on any materials they may use.**
- 3. Applicant assumes all risks and responsibilities surrounding the event and releases PSHA and any officers, directors, trustees, and agents from any and all liabilities, claims, or demands for damages for personal injury, disability, property damage or other loss of any kind that may sustain as a result of event, whether such loss results from the negligence of such released parties or otherwise (except for claims or liability arising directly from the gross negligence of such parties). Further, applicants agree to indemnify and hold harmless PSHA and the members, officers, directors, and agents of any of them from any and all loss, liability, damage or costs that it or they may incur as a result of participation or arising from any of my acts or omissions.**

- 5. Decisions regarding the award of scholarship funding are final. Applicants may not appeal the amount awarded or the events selected for the scholarships.**
