EVERY ENTRY AT THIS SHOW SHALL CONSTITUTE AN AGREEMENT AND AFFIRMATION THAT THE PERSON MAKING IT ALONG WITH THE OWNER, LESSEE, AFFILIATING ASSOCIATIONS, THE DIRECTORS AND EMPLOYEES HARMLESS FOR ANY ACTION, INJURY OR LOSS SUFFERED DURING NEGLIGENT ACTS OR OMISSIONS OF SAID OFFICIALS, DIRECTORS, EMPLOYEES, OR AGENTS OF THE AFFILIATING ASSOCIATIONS AND OR THIS SHOW. IT IS FURTHER AGREED THAT IF ANY DAMAGE, SICKNESS, INJURY, DEATH OR LOSS OCCURS TO THE EXHIBITOR, HORSES, ANY VEHICLE OR OTHER ITEMS WHICH MAY BE SENT WITH SAID HORSE, NO CLAIM WILL BE MADE AGAINST THE SHOW. I HEREBY AGREE TO MAKE NO CLAIM AGAINST PSHA OR ANY OF ITS OFFICIALS, EMPLOYED OFFICIALS, EMPLOYEES, OR VOLUNTEER WORKERS OF THE SHOW FOR ANY ACCIDENT WHICH MAY OCCUR TO ANY RIDER, DRIVER, ATTENDANT, ANIMAL OR EQUIPMENT AT THE SHOW; NOR IS SHOW MANAGEMENT RESPONSIBLE FOR LOSS OR DESTRUCTION OF ANY EQUIPMENT OR DAMAGES TO OR BY ANIMALS AT THE SHOW GROUNDS, STABLING OR PARKING AREAS. SHOW MANAGEMENT RESERVES THE RIGHT TO BAR ANY ANIMAL, EXHIBITOR, OWNER OR SPECTATOR FOR CONDUCT NOT IN THE BEST INTEREST OF THE SHOW. EXHIBITORS ARE NOTIFIED THAT ANY ACT OF DISCOURTESY OR DISOBEDIENCE TO THE OFFICIALS BY THE OWNER, RIDER, TRAINER OR GROOM WILL DISQUALIFY HORSE OR RIDER AND THE OWNER SHALL FORFEIT ALL FEES AND PAYMENTS. HORSES THAT EXHIBIT UNCONTROLLED BEHAVIOR WILL BE ASKED TO LEAVE THE RING OR GROUNDS. MANAGEMENT RESERVES THE RIGHT TO DECLINE ANY ENTRY AND TO CANCEL, COMBINE OR DELAY ANY CLASSES AS NEEDED. OWNER, AGENT AND EXHIBITOR(S) OR (PARENT/GUARDIAN) MUST SIGN, THEREBY ACKNOWLEDGING HAVE READ, UNDERSTOOD AND AGREE TO ALL RULES AND REGULATIONS.
