

**COVENANT NOT TO SUE, RELEASE, WAIVER OF CLAIMS, INDEMNITY AND
INSURANCE AGREEMENT**

This form must be completed prior to receiving services from The Canine Cooperative, LLC ("Company"). For renewing clients, this form must be updated annually during one of your visits to our kennel.

I, _____, ("Boarder") authorize The Canine Cooperative, LLC, ("Company") to kennel my dog, and if necessary, take my dog to my designated veterinarian or pet emergency clinic in the case of sickness or medical emergency. My veterinarian or emergency clinic may administer the proper medical attention necessary during which I, or other persons listed below, will be contacted for further approval of additional medical procedures.

If for any reason Company is unable to get to my designated veterinarian or emergency clinic in a timely manner, they may take my dog to _____ Company's designated veterinary hospital located at _____

This agreement is entered into as a condition of and a part of the consideration for the Company and its owner, Laurie Seigh, and the same individually, and the property owners, agreeing to allow me to kennel my dog or cat with Company on the property of the landholders located at 71 Worcester Road, Stowe, Vermont, or any other involvement with dogs, or any activities incidental, attendant, or related to the foregoing kenneling of my dog, including but not limited to, training, transporting and/or walking them:

1. Due to the nature of working with animals, there is no guarantee on training outcomes or specific activities conducted while boarding or training. I understand and acknowledge that any involvement with dogs can be hazardous and that kenneling involves numerous risks of injury and that dogs are often unpredictable and difficult to control.
2. I voluntarily and expressly assume all risks and dangers of such involvement in training and kenneling dogs.
3. I agree not to sue Company, or the landholder of property, Laurie Seigh, where any of the activities mentioned above may take place, and I waive and release any and all claims arising out of such activities or the use of such property, including but not limited to any claims alleging negligence, breach of contract, strict liability, or otherwise, of Company, or any such landholder(s). This covenant not to sue, waiver and release includes, but is not limited to, bodily injury, death, property damage, loss, contribution, indemnity or any other claims which I may ever have against Company, their agents or employees, or any landholder.
4. I also agree to defend, indemnify and hold harmless Company and any landholder involved from any expenses, damages or judgments, including any legal expense, reasonable attorneys' fees, claims for contribution or indemnification, resulting from claims by third parties arising out of any activities mentioned above, or the use of any property in relation to any such of my activities, including but not limited to dog bites, dog attacks, escape, lost dogs, or death of dog.

5. I also acknowledge and agree that I have, or it is my responsibility to obtain and keep in force, sufficient insurance coverage (including but not limited to dog liability, health and life) to protect me from any expense, liability, claim, or damages mentioned or included **in** this agreement and that whether or not I obtain such insurance and whether or not such insurance is sufficient, the provisions above shall be fully effective and enforceable and I will be bound and liable under such provisions.
