



## Area Scouts: Parental Consent Form

Area Scouts is a platform designed to assist athletes, with an emphasis on health initiative, development, ranking, and the resources for those athletes to reach their maximum potential. All while giving parents and athletes the recruitment tools and exposure to achieve their desires to play at the next level.

If your athlete is under the age of 18, this form is required for their inclusion in our platform.

It is important to read this entire document before signing it. Copies transmitted by facsimile or electronically are considered to be valid. Area Scouts is a voluntary platform with regard to both institutions and prospective student-athletes. No prospective student-athlete or parent is required to sign the Area Scouts consent form or join the Area Scouts network for said student-athlete to receive assistance and participate in athletics.

1. **Input of Information.** While there are informational requirements to create an Area Scouts profile, all further information, including personal information such as bio, medical history, schooling/educational information, athletic videos, evaluation grades, metrics and statistics, etc. is entirely created and or maintained at the discretion of the athlete and/or parent(s)/guardian(s) who have access to the account. Area Scouts does not take responsibility for the quantity or lack thereof, as well as the accuracy of information uploaded by users of the platform.
  - a. **NOTE:** All grades, metrics, and statistics are entered by trained / certified independent subcontracted evaluators, along with the results from our professional evaluations, regarding the performance of the athletes.
2. **Distribution of Information.** The Area Scouts platform is designed to input, store, rank, and distribute our athletes' information to aid in health initiative, performance and exposure to both recruiters/scouts. By signing this form, you are aware that all information entered into our platform can be accessed by directors, evaluators, scouts and recruiters on the platform, if the athlete chooses to make his profile public, however, athletes' information will not be released otherwise.
3. **Service Agreement.** While the Area Scouts team and platform will do everything possible to help your athlete stay healthy, and reach their highest level of success, we make no guarantees in regards to what that level of health and success is. We will do everything in our power to ensure the best results as possible for all of our athletes.
