# Excerpts from Letter Announcing Results of QI Dissolution

Dear Quota Members and Leaders,
At the request of President Emilie Simon, I wish to announce the outcome of the Quota International delegate vote on the Board of Directors' resolution to dissolve Quota International's structure. Because a majority of ballots approved the proposal, the resolution, below, passes. Quota's international structure will dissolve the later of September 30, 2020, or the sale of the final office suite, still owned.

251 Voting Delegates. Votes counted: 210 Approved, 11 Disapproved
Be it resolved that Quota International, Inc., shall dissolve no later than September 30, 2020, or within 30 days after the sale of the last Quota International, Inc., office unit.
Be it resolved that the 2018-2020 Quota International, Inc., Board of Directors term of office shall be extended until the date of the filing of the dissolution paperwork.
Be it resolved that the plan is to disburse a portion of the remaining Quota International, Inc., monies, if any, to Quota clubs in good standing as of October 1, 2019, in the form of membership dues refunds and/or other mechanisms as may be determined by the Quota International, Inc., Board of Directors and as reviewed and approved by the Quota International, Inc., financial and legal counsel.
