## How to reference the cambridge dictionary apa



To cite a dictionary definition in APA Style, start with the author of the dictionary (usually an organization), followed by the publication year, the word you're citing, the dictionary name, the publisher (if not already listed as author), and the URL. Generate accurate APA citations with Scribbr How to cite an online dictionary entry Online dictionaries tend to be continuously updated, so you usually won't have a specific publication date. In this case, write "n.d." (no date) in place of the year and include a retrieval date: Merriam-Webster. (n.d.). Citation.





Year of Publication: (2011). Next, in parentheses, list the year of publication, which appears on the title page or the title page verso (backside of the title page). Add a period after the parentheses. Title in the form of the Term: Noni. Next, add the term located or looked up in the dictionary. Capitalize only the first word of the title and subtitle and all proper nouns or names. End with a period. Title & Subtitle of the Book: In The American Heritage dictionary of the English language. Next, put the word "in" followed by the title. If there is a subtitle, separate it from the title by adding a colon. Capitalize only the first word of the title and subtitle and all proper nouns or abbreviations. Italicize the title but do not end with a period as the dictionary has an edition. Edition of the Book: (5th ed.). After the title of the book, add the edition number in parentheses. Add the abbreviation "ed." after the number. Place a period after "ed." and outside of the parentheses. Source Information: Houghton Mifflin Harcourt. Complete the reference with the name of the publisher. Put the publisher's name exactly as shown on the title page. Be sure to retain the spelling and capitalization as it appears on the title page. End the citation with a period. Kingfisher in the snow (Photograph). Flickr. Explanation Author or Creator: Trim, D. Begin with the reference with the person who took the photograph. The author may also be an alias or a group author. List the instructor's last name followed by a comma. Then, add the first and middle initials (if there is a middle initial). After each initial, add a period.

If there is a middle initial, add a space between the initials. Date of Photograph: (2021, January 24). Next, add the date the photograph was published. If the month and day are known, you may include this information. Be sure to list the year first, followed by the full spelling of the month and then the day. The date should be in parentheses and include a period after the parentheses. If there is no date listed for when the photograph was published, then use the abbreviation for no date, which is "n.d." Be sure to add a period after each letter of the abbreviation. Title of the Photograph: Kingfisher in the snow [Photograph].

After the date, add the title of the Photograph. The title should follow the general capitalization rule that says to capitalize the first word of the title and subtitle as well as proper nouns. The title should be italicized. After the title, add "Photograph" in brackets. Add a period after the brackets. Source Information: Flickr. Complete the reference by listing the name of the website where the photo can be found or the publisher of the photograph. In this case, it is Flickr. The website title or publisher should be capitalized but not italicized. Add a period after the website name or the publisher. In the event the photograph was found online, add the URL for the photograph. Do not add a period after the URL! Capitalize all initials in the title of the act. After the title of the act, add a comma.

Source: Minn. Stat. Next, add the official source for the state statutes. For Minnesota, it is the Minnesota Statutes. Use the official abbreviation, which is "Minn. Stat." Be aware that there is a period after each abbreviation, and there is a space between each abbreviation. Section Number: § 321.0101-1208 Next, add the section number of the statute. Before the section number, add the section symbol (§). Then, add the first section number, a hyphen, and the last section number. Do not add a period after the section numbers. NOTE: You can find the symbol for section numbers in Word by following these steps: click on the "Insert" tab, then "Symbol," then "More Symbols," and then "Section Symbols." Year: (2001 & rev. 2004). Next, add the year the statute was codified in the state statutes.

This statute was first codified in 2001.

It was then revised in 2004. After the date the statute was first codified, add an ampersand (&), then the abbreviation for revised (rev.), and then the date it was revised. URL: Complete the reference with the web address (URL) where the act can be found. For most course papers, you will want to remove the URL. Additionally, do not add a period after the URL. NOTE: Check your instructor's preference for live hyperlinks. In general, if the assignment is an online assignment (e.g., Brightspace discussion, webpage, etc.), then keep the live hyperlinks. If the assignment is a paper, then remove the hyperlinks.
