Time & Age rule (10yrs mbr/65 years old) and Distance rule (in excess of 50mi from Club) pay base dues (\$90.00)

Dates for dues and any penalties (late or non-payment) are described in Club By-laws.

All memberships are family memberships (described in By-laws). However, while all eligible family members can belong for one (1) price, any family member desiring to become a Club member must fulfill all other membership requirements (see By-laws).

New members joining in May, June or July will pay \$45 + \$10 (key fee) for a total of \$55.00

New members joining in August or September will pay the base dues. This amount will be applied to the upcoming year.

Club officers and life members pay no dues. Members of the Board of Directors will pay base dues.

Memberships (1 each) to local law enforcement agencies (Waterloo PD, Seneca Falls PD, Seneca County SD, Seneca County Probation Dept.) firearms training officers at no charge. This policy will be reviewed annually by the BoD.

Any member unable to use their membership due to active military service will not be penalized. Their membership will be "frozen" during their activation. Their time in service will be added to their membership upon return.

The BoD reserves the right to make exceptions to these rules based upon individual circumstances.

WRPC Release of Liability
READ CAREFULLY - This affects your legal rights

In exchange for participation in the activity of Individual Target Shooting, organized by Waterloo Rifle and Pistol Club ("WRPC"), of 1392 West River Road, Waterloo, NY 13165, and/or use of the property, facilities, and services of WRPC, I agree to the following:

1. I agree to observe and obey all activity rules and warnings and further agree to follow any oral instructions or directions given by the instructors, range officers or employees/representatives or agents of WRPC.
2. I recognize that there are certain inherent risks associated with the above described and I assume full responsibility for personal injury to myself or others and further release and discharge WRPC for injury, loss or damage arising out of my participation in the event and/or use of or presence upon the facilities of WRPC, whether caused by my fault or other third parties.
3. I agree to indemnify WRPC and hold same harmless from any cause of action, loss or damage, judgement, cost or expenses, including legal fees and other litigation cost which may, in any way, arise out of my participation in the event and/or use or presence upon the facilities of WRPC, whether caused by my fault or other third parties.
4. I agree to pay for all loss or damages to the facilities of WRPC or to other participants in the event which I may cause as a result of my participation in the event and/or use or presence upon the facilities of WRPC.
5. Any legal or equitable claim that may arise out of my participation in the event and/or use of or presence upon the facilities of WRPC shall be governed and resolved according to the Laws of the State of New York.

I have read this document and understand it. I further state that I am of legal age and of sound mind and not under the influence of alcohol or other substance that impairs my judgement. I understand that by signing this document, I voluntarily surrender certain legal rights.
