1. RESERVATION & SERVICES

Backyard Adventures, LLC ("Company") will provide the event rental, setup, removal, and/or party-hosting services identified above. The information on this page is the Customer's Reservation Confirmation and is part of this Service Agreement.

2. PAYMENT

Payment in full is due at the time of booking. The reservation is confirmed when required payment and booking documents are received. Additional charges may apply for approved extra time, excessive cleaning, damage or loss of Company equipment, or other agreed charges. A mileage fee may be added if the event is outside the Company's included mileage range.

3. CANCELLATION / STORE CREDIT

Payments are non-refundable. If the Customer cancels, amounts paid will be issued as Backyard Adventures store credit valid for one (1) year from the original event date, subject to availability when rescheduling. No refund will be issued after equipment delivery or setup has begun.

4. SUPERVISION

The Customer is responsible for appropriate adult supervision of children and other attendees throughout the event. Company staff may host, coach, organize, or lead activities, but are not a substitute for a parent, guardian, or responsible adult. The Customer will ensure attendees follow Company safety instructions.

5. EVENT AREA & EQUIPMENT

The Customer will provide a safe, accessible, suitable event area. Company equipment may not be moved, altered, intentionally damaged, or used contrary to instructions. The Customer is responsible for damage or loss caused by misuse or intentional acts, excluding ordinary wear and tear. Company may stop an activity or remove equipment when conditions are unsafe.

6. VENUE RULES

For a third-party venue, the Customer is responsible for obtaining required permission and complying with venue rules and applicable requirements, including any charges or consequences resulting from the Customer's or attendees' failure to comply.

7. WEATHER & SAFETY

Company may delay, modify, relocate, or discontinue activities when weather, site conditions, equipment concerns, participant conduct, or other circumstances create a safety risk. For circumstances beyond either party's reasonable control, the parties will work in good faith to reschedule or apply the Company's cancellation/store-credit policy as appropriate.

8. PARTICIPATION, RISK & LIABILITY WAIVER

The Customer understands that sports, games, relays, obstacle courses, physical activity, and use of event equipment involve inherent risks, including falls, collisions, physical exertion, and injury. **A separate Backyard Adventures Liability Waiver and Release is required for participants as applicable and is not replaced by this Agreement.** The Customer is responsible for ensuring required waivers are completed before participation.

9. COMPANY RESPONSIBILITIES

Company will use reasonable care in delivering, setting up, operating when applicable, and removing Company equipment and will provide the booked services described in this Agreement. Company may refuse or stop participation when conduct or conditions create a safety concern.

10. DAMAGE & INCIDENTS

The Customer will promptly notify Company of any injury, property damage, equipment damage, or other incident related to the event. Nothing in this Agreement is intended to waive rights or responsibilities that cannot legally be waived under Pennsylvania law.

11. GOVERNING LAW & CHANGES

This Agreement is governed by Pennsylvania law. The parties will make a good-faith effort to resolve disputes before formal legal action. Any changes to this Agreement must be agreed to in writing.

12. ENTIRE AGREEMENT & ELECTRONIC SIGNATURES

This signed document contains the Reservation Confirmation and Service Agreement for the booked event. Any applicable participant Liability Waiver and Release is a separate document. Electronic signatures and electronically delivered copies may be treated as originals.
