

MEMBERSHIP & SUBSCRIPTION TERMS

1. What Talent Bible Provides

Talent Bible is an advertising and directory platform. Members can have a profile created on the platform to advertise their services to potential customers. Talent Bible is not an agency and does not act as an agent for members.

2. Membership Options

The membership options are: (a) Monthly membership: £39.99 per month, recurring until cancelled. (b) 12-month membership: £19.99 per month for the first three months, followed by £39.99 per month thereafter, subject to the applicable subscription arrangement and renewal terms. (c) Yearly membership: £360 as a one-off payment for 12 months.

3. Automatic Renewal

Monthly memberships automatically renew each month unless cancelled. A 12-month subscription automatically renews for a further 12-month period unless cancelled at least 30 days before the renewal date. Where a yearly membership is set up to renew, it will automatically renew on the applicable renewal date unless cancelled at least 30 days before that date.

4. Cancellation

Members may cancel a recurring monthly membership at any time. Cancellation stops future renewals; the member remains entitled to the service for any period already paid for, subject to any applicable refund rights. Annual/12-month memberships must be cancelled at least 30 days before the renewal date to prevent the next annual renewal.

5. Payment

Card payments may be made through Stripe. Talent Bible does not take card details over the telephone. Members who do not wish to use Stripe may pay by bank transfer using the payment instructions supplied by Talent Bible. Failed, reversed or cancelled payments may result in the membership being suspended or terminated.

6. Profile Creation and Content

Talent Bible may upload photographs, videos and information supplied by the member and create the member's advertising profile. Members are responsible for ensuring that information and media they provide is accurate and that they have the necessary rights and permissions for Talent Bible to use it.

7. Public Advertising

Profiles are publicly accessible through TalentBible.biz. Members understand that contact details and other information included in their profile may be viewed by anyone visiting the website and may be used by potential customers to contact them directly.

8. Promotion

Talent Bible may promote its platform and members through social media, online advertising and other promotional channels. This may include photographs or videos supplied by members and, where appropriate, publicly available material relating to members, subject to applicable rights and laws.

9. No Guarantee of Bookings

Membership provides advertising and promotional exposure only. Talent Bible does not guarantee that a member will receive enquiries, bookings, employment or a particular level of business. Customers decide independently whether to contact or hire a member.

10. Direct Booking Relationship

Customers contact members or their nominated agents directly. Members are responsible for agreeing prices, availability, contracts, performance arrangements and other booking terms with their customers. Talent Bible does not arrange or guarantee bookings.

11. Suspension or Termination

If a membership payment is not received by the due date, a recurring payment fails, or a member cancels a payment mandate, Talent Bible may suspend or terminate the membership once the issue is identified. The member's profile may then be deactivated. Talent Bible may also remove or suspend content that it reasonably considers inappropriate, unlawful, misleading or harmful to the platform.

12. Deactivated Profiles

When membership ends, Talent Bible may turn the profile off rather than permanently delete it. This allows the profile and information to be retained for potential reactivation if the member rejoins. A former member may request deletion of personal information in writing, subject to applicable legal retention requirements.

13. Refunds

Any refunds will be handled in accordance with applicable UK consumer law and the specific circumstances of the membership. Nothing in these terms is intended to remove or restrict statutory consumer rights.

14. Changes to Membership Terms

Talent Bible may update membership pricing or terms from time to time. Where a change materially affects a recurring subscription, appropriate notice will be provided as required by law.
