***It is the responsibility of DF Precision management to:***

- 1. Ensure that the Environmental Policy is monitored and updated annually.*
- 2. Seek to continuously develop so as to minimise environmental impact as far as it is practicable.*
- 3. Classify, organise and dispose of all regulated and hazardous materials in a manner consistent with regulatory requirements.*
- 4. Define all waste materials and emission discharge points.*
- 5. Develop systems to monitor waste materials in order to minimise time awaiting disposal.*
- 6. Provide training to its employees in environmental awareness.*

### **1. MONITOR AND MAINTAIN POLICY**

- 1.1 It is the responsibility of DF Precision management to ensure that the environmental policy is monitored and maintained on a regular basis.*
- 1.2 Environmental issues will be discussed, and any necessary compliance action recommended, both in DF Precision Safety meetings and at the management meetings.*
- 1.3 All appropriate environmental compliance points will be reviewed and monitored to ensure that the proper actions are initiated*

**2. CLASSIFY, ORGANISE AND DISPOSE OF REGULATED AND HAZARDOUS MATERIALS**

- 2.1 *All known hazardous and regulated materials will be classified and organised in terms of their disposal requirements.*
- 2.2 *Waste materials will be subject to evaluation either by internal resources or by externally appointed consultants.*
- 2.3 *All applicable materials will be disposed of in a manner required by Environmental legislation and documented evidence of disposal retained.*
- 2.4 *Notification will be given to a licensed waste handler to provide disposal procedures consistent with environmental or health and safety regulations.*

**3. DEFINE ALL WASTE MATERIALS AND EMISSION POINTS**

- 3.1 *All waste materials and emission points will be defined and maintained on an official listing.*
- 3.2 *Listings will be monitored periodically to ensure that all materials are properly accounted for and all appropriate information is included.*

**4. PROVIDING TRAINING**

- 4.1 *Employees responsible for the proper maintenance of the Environmental Policy will receive the documentation and training to satisfactorily carry out those duties.*

**5. GIVING BACK TO OUR PLANET**

- 5.1 *DF Precision has and will fund the planting of one tree for every order we receive, no matter how small the value.*

*DF Precision will **also** plant 3000 square meters of woodland in the UK each year through the National Trust.*
