\_\_\_\_\_ The kitten will not leave Breeder's care earlier than 12 weeks of age. When no breeding rights are given, the kitten will be spayed/neutered around 12 weeks of age and will not leave Breeders care earlier than 14 weeks of age. Health conditions may extend the kitten's stay.

If the kitten is not collected within 3 days of the agreed upon date of exchange, Buyer agrees to pay \$15 per day for boarding until the kitten is collected.

If Buyer is not able to collect the kitten in person, Breeder can help arrange transport. The price of the kitten does not include delivery and Breeder is not responsible for this cost. Unaccompanied transport is not possible. If a courier is used, he/she is the proxy of the future owner and is fully responsible for the kitten. Buyer must provide video confirmation of the completed delivery.

All transport costs involving this kitten will be at Buyer's expense.

\_\_\_\_\_ Breeder ensures that the kitten will receive his/her first and second round of vaccinations, a microchip implant, and will be on a deworming schedule.

Buyer will receive Pet Health Record, TICA pedigree certificate, transfer document, information about care, and a bag of goodies from Breeder.

It is strongly recommended that the kitten remain in quarantine away from all other pets for at least 10 days, beginning at the time of arrival.

It is also strongly recommended that pet insurance is kept on the kitten for his/her lifespan.

\_\_\_\_\_ Buyer has 2 business days to have the kitten examined by a licensed veterinarian in a licensed veterinary clinic at his/her own expense. Veterinary costs are not refundable.

Buyer has 1 week to submit proof of veterinary examination to Breeder. Failure to do so voids the health guarantee.

\_\_\_\_\_ If the kitten is found to be medically deficient with an untreatable or life-threatening problem during the initial vet exam, medical records must be hand-signed by the veterinarian and returned to Breeder immediately.

Buyer may wish to keep the kitten, despite being diagnosed with the medical problem(s) and agrees to treat the problem at his/her own expense. The health guarantee is then void and Breeder is no longer legally or financially liable for the kitten.

Breeder reserves the right to demand the return of the kitten for his/her treatment. If this happens, medical expenses will then be paid for by Breeder.

If Buyer does not wish to keep the kitten, he/she will be returned to Breeder at Buyer's expense, and medical expenses will be paid for by Breeder.

If the kitten expires during treatment while in Breeder's care, a refund will be issued, less the nonrefundable deposit and associated transport fees, or a replacement kitten of equal value will be provided from one of the next 3 litters. If Buyer does not choose a kitten within that time, the offer is forfeited.

\_\_\_\_\_ Breeder does not warrant against any viral infections or other common cat conditions after the kitten has left Breeder's cattery and past the initial 2 day vet exam, such as ringworm, FIP, coronavirus mutations, etc.

Buyer understands that it is possible for the kitten to get sick due to the stress of travel, dietary changes, and changing environments, and that veterinary documentation is required in writing for diagnosis.

Breeder is not responsible for hidden defects, mental or physical development, temperament, or appearance of the kitten.

Breeder cannot guarantee the kitten's success in shows.

\_\_\_\_\_ Buyer certifies that he/she is not an agent for another person or institution and is purchasing the kitten for his/her own purpose.

Buyer promises that the kitten will live indoor and will only be allowed outdoors under supervision and in a fully enclosed environment, i.e. catio.

Buyer agrees to keep the kitten in a clean and healthy environment, free of fleas and fungus, with proper nutrition and companionship necessary for their well-being.

Buyer agrees to provide the kitten with high qualified veterinary healthcare and to continue routine parasite control and annual vaccinations.

Buyer is required to check in at least every 6 months until the kitten is 2 years old. Updates should include at least 2 pictures or videos per update. This is to ensure Breeder that the kitten is well. In the case of illness, Buyer should inform Breeder immediately.

\_\_\_\_\_ Buyer is not permitted to mate this Maine Coon kitten to any other breed.

It is strictly forbidden to surgically remove the kitten's claws (declaw).

Buyer understands that the kitten cannot be sold or given away, period, including being surrendered to a shelter, without the consent of Breeder at any age. There are no exceptions to this condition. If Buyer can no longer care for the kitten, Breeder reserves the right to either help make arrangements for the care of the kitten or take him/her back as a surrender no matter the age of the kitten at Buyer's expense. However, Breeder is under no obligation to do either option. This contract will remain in effect with any new placement.
