On March 11th Dr. Courtney Ray made his first visit to the Biloxi Lions Club with slideshow on cornea transplants. It starts out quoting Helen Keller's request at the 1925 Lions Convention for Lions to be the champions of the blind.

Dr. Rey trained at the Mason Eye Institute where he completed both a residency in Ophthalmology and a Fellowship in Cornea and Extended Eye Disease. He a Board Certified Ophthalmologist practicing in Florida, California and Mississippi.

His presentation to the members included cornea donation eligibility, yearly donation numbers, harvesting procedures and time allowed for harvested corneas to be transplanted into recipient patient.

We are sure that Dr. Ray will not be a stranger to the Biloxi Lions Club in the future.
