#### **David vs Goliath**

It's a strange title, but it comes to mind for this modern day tale of a small local businessman against an international conglomerate.

Our first speaker in September, Jeffery O'Keefe, CEO Bradford-O'Keefe Funeral Homes, Inc., shared this real life David vs Goliath story in which his father, Jerry O'Keefe, started and finished with an unbelievable ending.

While the whole affair was many years in duration, it started in 1994 when Jerry filed a \$5 million dollar breach of contract lawsuit against Canadian based funeral home consolidators, The Loewen Group, over insurance sales/purchase agreement.

The 1995 Jackson, MS, month
long trial ended with the jury awarding Bradford-O'Keefe not only the
\$5m but also added punitive damages reaching \$500m (8 of the 12 jurors wanted to award \$1B.)

corporation (Goliath) with the largest State of Mississippi jury awarded monetary verdict up to that time.


The Loewen Group knowing it could not pay the award verdict of \$500m, or the later agreed upon settlement amount of \$175m, filed for bankruptcy protection

But wait, there is more to finish this story. Throughout this story I have used the term international conglomerate as The Loewen Group was, as I mentioned, based out of Toronto, Canada. Its holdings in the US reached over 700 funeral homes and 109 cemeteries. After their lost 1995 jury trial Loewen fires back saying it did not have a fair trial in the United States or in the State of Mississippi. Loewen cries that its business practices were protected under the North American Free Trade Agreement (NAFTA.) The feds launch their own investigation against The Loewen Group for violations of anti-trust and discrimination laws while they were during business in the United

Jeff closes his talk on this fascinating family story by saying that the drama in month long trial was right out of a John Grishman novel. And, in fact, there was talk at one time of making a movie. Who knows, tomorrow is another day...
