# Mississippi's Secretary of State Michael Watson Visits the Biloxi Club

It was a very special day for the Biloxi Lions to have Michael Watson, Mississippi's 36th Secretary of State join us as our guest speaker. Accompanying Sec. Watson from his staff was Ray Carter, Tideland Lease Specialist, and Kelly McMullan, attorney.

Secretary Watson is a MS Gulf Coast native from Pascagoula and a former member of the Mississippi Senate claims the Gulf Coast is his passion but the whole state of MS is in his sights for what it right. His office oversees many avenues of the state from elections and voting, public services, licensing, to state owned lands.

Elected in 2019 Sec. Watson states he was elected to serve Mississippians and proceeded to do so by implementing 'Tackle the Tape' to navigate the red tape and cull out the obsolete and/or just plain bad state regulations from the over 118,000 regulations on MS books. Anything that is just not good business related regulations is being addressed through the State's 29 Boards and Commissions and it is calculated that by 2029 all 118,000 regulations should have been reviewed and addressed accordingly.

One such implementation is cleaning up each County's voter rolls to ensure fair and clean elections are held for the 2.9m citizens in the state. Tis process has started by meeting with each county Election Commissioners. The SoS website feature 'MyElectionDay' was designed to help qualified voters through the election process such as voter locations, candidates and even tracking of their absentee ballot.

After explaining about the state owned lands Sec. Watson introduced Ray Carter, Senior Attorney for Tidelands, who presented a power point presentation on the Public Trust Tidelands.

The 40 pages of the power point covered everything from the legal description and definitions of the Public Trust Tidelands, the history going back to the 6th century in Roman Law to 1957 Mississippi Supreme Court ruling that 'the shores of the sea below the high water mark belong to the state as trustee for the pubic" and again in 1986 when the Court held "Title to all lands naturally subject to tidal influence, inland to today's mean high water mark, is held by the State of Mississippi in Trust."

The 1986 Mississippi Supreme Court doctrine holds particularly special attention for the Gulf Coast as it directly addressed the tidelands for the purpose of future dockside gaming ventures seeking operations in Mississippi. By reiterating the coastal land under the sea as Tidelands, leases then generate income from the Corporate Gaming operations. You want to use the tideland under the sea, then you must file application to for a lease. The Tideland Leasing is enforced by the Secretary of State's office as the Secretary of State is the Trustee of the public land. Complicated, yes.

In closing, Secretary Watson stated "it is important to have coast constituents in his corner' to give him feed back on the pulse of the coast. A lot of what happens on the coast affects the rest of the state. For more information on the Secretary of State office go to www.sos.ms.us

In the 8.16.2023 ROAR Edition, the Mississippi Sound Coalition's mission was to work with state and federal leaders to find national solutions to the problem of the freshwater damage to the Mississippi Sound when the Bonnet Carre Spillway was opened for 118 days in 2019.

<sup>1</sup> After a suit filed by the Coalition against the U.S. Army Corps of Engineers and the Mississippi River Commission, a U.S. District Court Judge on January 18, 2023 ruled "the U.S. Corps of Engineers must consult the National Marine Fisheries Service about ways to avoid future harm to fisheries habitat in the Mississippi Sound and Lake Ponchartrain caused by openings of the Bonnet Carre Spillway."

The next step according to Blessey is to offer our facts and mitigation methods to National Marine Fisheries Service to use in meetings with the Corps as directed by the Federal Court.
