General Data Protection Regulation (GDPR)

We are a Data Controller of your information.

Bodhitreejuiceco.com legal basis for collecting and using the personal information described in this Privacy Policy depends on the Personal Information we collect and the specific context in which we collect the information:

- bodhitreejuiceco.com needs to perform a contract with you
- You have given bodhitreejuiceco.com permission to do so
- Processing your personal information is in bodhitreejuiceco.com legitimate interests
- bodhitreejuiceco.com needs to comply with the law

Log Files

Bodhitreejuiceco.com follows a standard procedure of using log files. These files log visitors when they visit websites. All hosting companies do this and a part of hosting services' analytics.
