Drilling and operating permits:

(A). Summer Field Farms, located at 2207 Hwy 79 E, New Summerfield, TX 75780 applied for a drilling and operating permit for one (1) well for agriculture use. The General Manager has recommended proposed drilling and operating permits to authorize maximum annual groundwater production from this well in gallons and at an estimated maximum rate of withdrawal in gallons per minute (gpm) as shown below:

Well Name	Potential Max Annual Production	GPM
Well 2	91,980,000 gals	175

The General Manager has recommended approval of the total usage applied for of 25,000,000 gallons or 76.72 acre-feet annually at the rate of 175 gallons per minute.

(B). Kevin Vu, located at 2020 ACR 1232, Palestine, TX 75801 applied for drilling and operating permits for two (2) wells for agriculture use. The General Manager has recommended proposed drilling and operating permits to authorize maximum annual groundwater production from the wells in gallons and at an estimated maximum rate of withdrawal in gallons per minute (gpm) as shown below:

The General Manager has recommended approval of the total usage applied for of 175,000 gallons or .53 acre-feet annually at a rate of 45 gallons per minute.

The General Manager has recommended approval of the total usage applied for of 175,000 gallons or .53 acre-feet annually at the rate of 45 gallons per minute.
