3. **Cancellation Policy:** Cancellations must be made in writing. The deposit is non-refundable. However, we will work with you to reschedule the session if notified at least 14 days in advance, subject to availability.

## Deliverables

1. **Delivery Timeframe:** Edited photos and/or videos will be delivered within 6-8 weeks from the date of the event/session.
2. **Delivery Formats:** Deliverables will be provided in digital formats (JPEG, MP4, etc.) and can be delivered via online download, USB drive, or other agreed methods.
3. **Revisions:** Clients are entitled to one round of minor revisions. Additional revisions may incur extra charges and will be billed accordingly.

## Rights and Usage

1. Client Usage Rights: Upon full payment, clients receive the rights to use the photos and videos for personal or commercial purposes as specified in the contract.
2. C1ststudio Usage Rights: C1ststudio retains the copyright to all photos and videos produced. We reserve the right to use the images and videos for promotional purposes, including our portfolio, website, social media, and marketing materials. Clients can request in writing to opt-out of such use prior to the event/session.

## Liability and Disclaimer
