Programme of Activity January - March 2024



Since April 2023, the National Children's Bureau has been working with providers and local authorities offering supported accommodation for looked after children and care leavers aged 16 and 17 to ensure they are able to register with Ofsted and implement mandatory national quality standards.

Through our sector awareness and provider preparedness programme, we published a series of 12 resources, delivered over 40 events, reaching over 1000 providers and 120

local authorities.

Following the closure of the registration window for existing supported accommodation providers in October 2023, we have been developing a programme of activity focused on ensuring that supported accommodation providers and local authorities engage with every stage of the Ofsted registration process and inspection regime, as well as enabling providers to implement the national quality standards.
