

Insulated Glass Warranty

Installation Warranty:

Distinguished Glass warrants the quality of its installation of the Insulated Glass Unit (IGU) for the lifetime of the product. This warranty is transferable to subsequent homeowners.

Manufacturer's Warranty:

The manufacturer of the IGU provides a five-year limited warranty against defects in materials and workmanship that result in fogging or moisture between the panes.

Warranty Coverage:

• Replacement of the defective IGU.

- **Labor Costs:** Labor costs for the installation of a replacement IGU are the customer's responsibility and are not covered by the manufacturer's warranty.
- **Transferability:** The manufacturer's warranty is transferable to new homeowners for a period of five years from the date of installation.
