

## DRAIN WATER HEAT RECOVERY PIPE



INSTALLATION INSTRUCTIONS


- In the 3" ABS drain water stack pipe, cut out a section 43" in length, making sure to cut at a 90 degree angel.

  Clean and sand any jagged ends where you have cut the pipe.
- Install shielded couplings at both ends of the Drain Water stack. (as shown in figure 2) Ensure the coupling is fully inserted squarely onto the 3" ABS pipe.
- a) Insert the Drain Water Heat Recovery unit into the shielded couplings and center the unit making sure of a good connection. Note: Incoming and outgoing PEX connections should be directed towards your water heater.
  - b) **NOTE:** Always install the Drain Water Heat Recovery device with the "inlet" port at the top position.
- Tighten the shielded coupling Hex bolts ensuring a water tight seal. Note: Do not over tighten as it may cause damage to the 3" ABS drain pipe and the Drain Water Heat Recovery unit.
- Turn off water supply at the Water Main Valve.
- After the installation of the Drain Water Heat Recovery device is complete you may begin connecting the Water supply pipes.

First, wrap the threaded end of the ¾" PEX adapter with Teflon Tape and screw into both the Inlet and Outlet ports until a water tight seal is achieved.

Insert the ¾" PEX tubing onto the ¾" insert fitting at the Inlet and Outlet ports and crimp connection to provide a water tight seal.

- Turn on Water and check for any leaking connections.
