For many of us, we are still grieving what we have lost. The wonderful dinners, the fund-raisers which helped us support important community projects and our own compassionate ministry, even our coffee hours which helped us stay connected with each other, have been a painful loss. Of course, we can take comfort in the knowledge that this too shall pass and life will return to something that resembles normal. We will once again enjoy our life in a robust and vibrant community of faith that loves to care for others in very tangible ways.

We do not need to apologize for who we are and what we love to do as Christ's people and we do not have to feel guilty about the loss we feel these days. But we can also rejoice that we have found some new ways to share and live our faith and we have remained creative even in the face of all the limitations we have faced. It is good for us to do everything we can to foster our life together in Christ and to uphold each other in our holy work.

After several attempts at setting a date, and being frustrated by Covid restrictions, we were able to celebrate Confirmation this past year on Reformation Sunday, celebrating God's grace in the lives of our wonderful youth.

We had a very good start in Lent this year and I was so please, maybe even a bit surprised, by how many came to our mid –week Night Prayer after our Community Dinner. Some of that came about because we were not shy about inviting people to worship with us and about celebrating the faith that unites us in Christ.

Until the Covid lockdown we had a very active ministry in our community's residences and Nursing Homes celebrating the Eucharist weekly in almost all of them working with the Anglicans to make this possible. I am certain this will resume after the lockdowns ends, as it was a wonderful ministry and a sign of our unity in Christ.

Our parish has experienced considerable grief this year, as many if not most of our families have mourned the passing of loved ones. We have upheld each other in these difficult times and celebrated the faith and hope that is ours, even when those celebrations were made difficult because of Covid.

I made the difficult decision to end my time of work at Zion at the close of the year as I struggle with some health issues. If I had continued, I am fairly certain it would not have ended well and I have always been a fan of happy endings.

This past year has been such a challenge for everyone. During our first lockdown many members turned to jigsaw puzzles to fill our time and in some cases relieve our stress. I picture 2020 as a puzzle (my favorite size to work is 1000 pieces). In January we began putting plans together for the coming year. First on my agenda is the preparation for the annual meeting. For other committees they began their yearly planning as well. This is the outside boarder of the puzzle. All pieces in place. On January 30th the World Health Organization declared a global emergency and we began to be familiar with the Covid19 virus. It didn't impact us directly so plans continued and the first pieces of the puzzle were put in place. We held our annual meeting late February and plans for the Lenten dinners began. More pieces of the puzzle were in place. We held 2 of our Lenten dinners with the first one being sold out. In March the WHO declared a global pandemic and things started to happen quickly. Italy was in a complete lockdown with death totals rising over 8,000. On March 18th the border between Canada and the USA was shut down, no more travelling south for vacation. How was this going to affect us in Pembroke and in our church? On March 29th the lockdown was in effect. We were no longer able to hold in-person services. A maximum of 10 people could meet at a time. Would we be able to open again for Easter? It was like a grandchild looking at the puzzle and accidentally knocking some of the pieces out of place. A small group of members decided that we would step outside of our comfort zones and figure out how we could tape our service, with only 10 people in the sanctuary and post it on YouTube. With lots of trial and error our first service was available May 10th. It was also recognized that many of our members were unable to view our services on-line so a small group of

dedicated volunteers delivered a print copy of the service and for some, a copy of the DVD we produced. This new ministry was so very welcomed by our shut-ins and will continue as long as needed. We continued to tape over the summer months and decided that this ministry would continue long after the lockdown. A large piece of the puzzle was put in place. In June we heard that we could possibly meet again for in-person services. Our Synod office put together a team that would give us guidelines that we could use for re-opening as it would look very different from anything we had seen before. The council met to discuss and approve opening for in-person services. Worship and Music met to review the multi-page check list, assign duties and ensure all was ready for September 13th. The puzzle continues to be built. Members were required to maintain the 6-foot social distancing as they entered the church building. All must wear a mask; hand sanitize and be registered. Upon entering the sanctuary, they were guided to their seat as the social distancing again needed to be maintained. One of our biggest challenges as a congregation was to sit quiet and not SING. We were so very happy to be with our church family again that it became a small issue. The puzzle is now coming together well with only a small space left to complete. We are now using our new recording equipment to tape and have been able to use the local Cogeco cable network to post our services as well. Then that small child returned to view the puzzle. I know they didn't mean to break a portion apart but that is often the result of curiosity. We were notified by Pastor Stephen that due to health issues he would be retiring as of December 31st, 2020. A call committee was formed and our pieces were put back into place. Now it was time to begin planning for Christmas Eve. Council along with the Worship and Music committee met to decide how we would put together our Christmas Eve services while complying with the Covid19 guidelines. It was decided that 3 services would be held, 11:00 a.m., 3:00 p.m. and 7:00 p.m. Time was needed to sanitize the sanctuary between services. Members would need to call and register for the service they would be attending as we still had a limited number of people that could attend the services. On Sunday December 20th rumors hit that we would be in a complete lockdown again beginning December 24th. A small group met on-line and put in place plan B for Christmas eve just in case the rumors became true. At around 1:30 p.m. on

Decemer 21st it was announced that the lockdown would occur on December 26th. We could hold our Christmas Eve services in-person. What a relief. It was when I attended one of these services with my Mom, daughter and granddaughter that I felt the peace and joy that Christmas brings. I felt the Lords hands on my shoulders and knew that I was safe and so happy to be here. Only 1 more puzzle piece to put in place. Since we were back into a lockdown, we planned to record a service on December 31st. This would be our last recording of 2020 and what we hoped would be our first to be shown in 2021. We were very blessed to have Pastor Stephen participate in this service, on his last working day with Zion.

Our puzzle is now complete. The picture is not what we would have expected to see in January. So many important events were missing. Funerals could not be held as we normally could. Weddings had been postponed. Our social gatherings, Lenten dinners, pie day, coffee hours, ZLW meetings and so many more events did not happen. A time will come when we will return to these times together again and we will appreciate them so much more due to their absents.

I want to thank the Church Council for all of their efforts this year as we maneuvered down an ever-changing road. As well I need to thank the Worship and Music committee for their tremendous efforts to make sure we followed all of the necessary rules to keep our members safe. A big thank you to all of our committees who work hard without direction to get jobs done. It makes my life so easy. Thank you to Jean for all of your work in keeping things running smoothly and to Kevin for making sure our building and yards are kept in perfect shape.

A warm and sincere thank you to Pastor Stephen for his leadership during this difficult year. You helped to keep our world calm as we road the wild waves of the Covid 19 storm. We pray that God will bless you with recovered health. All the best to you and Jan in your retirement.

I need our congregation members to know that even though we have not always been able to be together that every one of you remain in our hearts and prayers.

 - Schmeider Hall got a new kitchen style stove that can be used by renters
 - The Comfort Station started construction in September 2020; it will be completed this winter

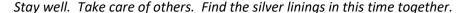
- o Carpentry work and changing locks was undertaken

Property Committee Report for 2020

The members of the property committee are Don Boldt, Dan Dole, Richard Faught, Al Kellough, Wayne Reiche, Kevin Rutz, Barry Schizkoske, Brent Wolfgram, Gerry Vandersleen and Wilmer Verch.

Heating pipes were repaired and some were replaced behind the quilters' room and in the boiler room. Some modifications were made to improve efficiency. Pipes were insulated to reduce energy consumption and improve temperature control in certain areas.

Photocells were replaced to get all the exterior security and entrance lighting to work properly.

In March a team of volunteers removed deep snow from the roof over the foyer in front of the washrooms at the elevator. By removing the snow dam water was able to drain away and not leak inside.

Eaves troughs were repaired and replaced around the Parish Hall and Administration building.

This past summer Celebrity Flooring was contracted to deep clean and refinish the Parish Hall floor while the building was closed due to Covid-19 restrictions.

A new handrail was installed on the chancel steps at the lectern.

When the roofers that were contracted to replace the mid section of roof around the elevator left the roof open in August, rain flooded the interior resulting in extensive damage. Ceiling, lights and flooring had to be replaced in the lounge and foyer. Some walls had to be repaired and painted, mostly at the expense of the contractor.

Floor signs were procured and installed to remind worshippers of physical distancing while entering and exiting from in-person worship service during easing of Covid-19 restrictions.

A couple more control valves and steam traps were repaired at the start up to the heating season.

The Parish Hall roof was repaired on the parking lot side and new snow/ice stops were installed.

A new railing was installed on the east side stairs to the choir loft. A new railing was also installed from the parking lot/drop off area at the outside entrance to the elevator foyer.

A few shingles on the Sanctuary roof suffered wind damage and were replaced.

The 401 Munro Street apartment basement needs some significant repairs and up grading. These were delayed because of the pandemic restrictions but will have to be addressed in the near future. Members of the property committee replaced the failed bathroom exhaust fan.

Another stained glass window remains to be repaired in the Sanctuary.

Funding is needed for building maintenance. Some brick and mortar repairs are required on the walls and chimney. Parging repairs are needed on the main entrance stair wells.

The surface of the ramp at the east side entrance is becoming irregular and will have to be repaired or replaced. The parking lot surfacing also needs to be repaired.

We wish to express a huge thank you to our custodian for his dedication during the pandemic for his cleaning and thorough disinfecting after each use of the Parish Hall, Sanctuary and washrooms. Thank you also the general up-keep of the premises inside and out over the past year.

Social Ministry Annual Report 2020 Year 1 of the Covid 19 Pandemic

Zion's Social Ministry team is a hard-working dedicated group of tireless volunteers striving to bring light into the world with acts of kindness and love with the generous support of the entire congregation.

Listed below are the activities worked on:

- Soup and Sandwich luncheon was held Sunday January 12 with 30 people in attendance due to a terrible snow storm. Amazingly, we raised \$210.00 which was sent to The Renfrew Hospice.
- \$500.00 from the PSSAM (post secondary student assistance ministry) was given to a post secondary student in need.
- Debbie Sitkiewitz continues to purchase non perishable food for food bags we keep on hand at the church in case someone comes to the door needing food.
- Social Ministry sponsored the Shrove Tuesday Pancake/Sausage/Baked bean and Hash Brown Dinner held Tuesday February 25th. 60 people attended with free will offerings. The baked beans were donated by: Denise Schizkoske, Gayle Seegmiller, Patricia Wegner and Ellen Vandersleen. The fruit cocktail was donated. The proceeds of \$490.00 was donated to St. Joseph's food bank. Our first fruits giving for the upcoming Lenten Dinners.
- A new event Zion participated in this year was **The Coldest Night of the Year Walk** supporting the Grind -Pembroke's community kitchen for the hungry and transitional housing for the homeless. Zion raised \$1,170.00. The total Pembroke raised was \$30,000.00. Gayle Seegmiller, Koit and Diane Rull and Ellen Vandersleen walked 10 km.
- On January 21 we combined batch cooking for our senior shut-ins with a boys and girls club dinner. We delivered the shut-in meals to their homes. The Boys and Girls Club dinner was dropped off at Wesley United Church where the children meet. A full day's work.
- We provided 10 meals for our shut-ins and 10 vouchers for our soup kitchen attendees for our first Lenten dinner. Due to the Pandemic lock down the

- remainder of the Lenten dinners were cancelled as was most other events of the spring and summer.
- During the pandemic it was realized that in order to keep our members connected to God's Word and parish news a delivery service of bulletins, announcements and Guiding Light newsletters were taken to people weekly who did not have computer access. They could read the printed service and keep up on parish life. This service was initiated by Jan Scheidt. Thank you, Jan! Thank you to Denise Schizkoske, Koit and Diane Rull, Jan Scheidt, Debbie Sitkiewitzand Cheryl Sack for this outreach service. There were about 70 homes we delivered to.
- Another new venture we started this year was Zion's Community Garden. It is located on the empty lot adjacent to the parking lot. Kevin Hoffman donated a load of top soil in May 2020. Gerry Vandersleen leveled out the soil with the tractor. Heather and Ellen Vandersleen planted, weeded and occasionally watered the small garden of beans and potatoes. A special thank you to our harvesters: Don Boldt, Gayle Seegmiller, Jan Scheidt, Lyndsay Johnson and daughters Everly and Blythe, Al Kellough, Patricia and Peter Wegner and Pastor Stephen Scheidt. Our little garden yielded 32 lbs of beans and 150 lbs of potatoes. All organic. This food was donated to St. Joseph's Food Bank. In September Susan Dupuis applied for and received a \$2,000.00 grant from the Emergency Community Support Fund from Community foundations of Canada. H & H Construction donated a load of topsoil which was dumped late in the fall. Come spring we will be ready to expand our garden plot. We are working on getting water hooked up. Tools will be purchased and other supplies that gardeners need. How exciting!
- Jam Jar Fundraiser this year was designated for Canadian Lutheran World Relief's Gifts from the Heart program. Zion was most generous and we raised \$1,566.40.
- As the pandemic dragged on and gave us challenges we had never before had to face we decided to prepare our seniors a dinner to let them know we hadn't forgotten them and to share our love. A small group of volunteers from Social Ministry and The Lenten Supper Group got together wore masks and hair nets and made Zion's delicious turkey pies plus much more. We prepared and delivered 67 meals. We made some extra turkey pies which we sold which in turn paid for the supplies of the entire meal plus.

Sunday School 2020 Annual Report

Membership:

The superintendent position was held by Penny Stalkie.

Activities & Events:

2020 was a year filled with great learning experiences. This is where I would say we did fun filled crafts and activities and furthered our relationships with Jesus. 2020 was very different. We were preparing for Easter Sunday one day and went into lockdown the following day. Classrooms were left empty with our Resurrection Eggs Craft incomplete. Total scheduled enrolment as of September 2020 was approximately 32 students. The average weekly attendance was 10 students per Sunday. These numbers are incomplete as they are based on just the first 8 weeks of 2020.

Our class arrangements remained the same throughout the year with the exception of a few teacher changes. The 3 year olds, Junior and Senior Kindergarten class was taught by Melissa Boldt, Kim Wolfgram-Schmidt. Grades 1 and 2 were grouped together and led by Keanna Mackinnon, Merrie Hammel and Nadia MacKinnon. Grades 3 and 4 children were led by Krista and Alex Hammel. Grades 5 and 6 gathered together and were led by Penny Stalkie. Mollie Reid, Jamie Landon, Mollie Hoffman, Daniel and Jayne Reid and Hannah Schmidt assist in various positions or classrooms each week. Due to the low number of children coming to Sunday school in the first 2 months we combined all the children into one room and worked together as a team.

Once the church received permission to open again, the children that attended remained in worship with their families. Each Sunday I prepared "Ziploc Packages" that contained the weekly lessons as well as a variety of crafts to meet a variety of age groups. I started with 10 per Sunday but dropped down to 5. Due to the fact that I suffer from extreme claustrophobia (something I wasn't aware of until Covid hit and masks became a requirement) I am unable to attend services. Wearing a mask causes me great distress. I have been given approval to wear the plastic shield should classes start up again.

We will continue to use the Whole People of God Curriculum (WPOG) that follows a 3-year lectionary cycle. A subscription runs from September one year to June the following year. The materials can be accessed directly by teachers online as well as copies of all lessons are made available on sight. I did not purchase the new subscription this year (September 2020) as I have accumulated enough resources to prepare the "baggie lessons". I still follow a lectionary based system. Should we return to regular classes, I will decide if it is cost effective to make the purchase at that time.

In closing, I would like to take this opportunity to thank all our fellow teaching staff for their continued efforts and hard work. The Children's Ministry is a very important part of our family here at Zion. It may only be for an hour each Sunday but for those attending, it's the basis of a foundation for the rest of their lives. For those preparing and presenting it's a

passion and a challenge to provide a warm and inviting environment that teaches God's love. When we all come together with a common goal, share our time and ideas and work together as a family we create an environment that our children want to be a part of. We know that the task of a Sunday School teacher is a great one and we pray that with God's love and guidance, we will continue to provide a successful children's ministry. God willing, we will soon return to "normal".

2020 has been a year like no other due to the COVID-19 pandemic. Our January Epiphany service was a beautiful and inspiring service, February focus on 'Love letters from God' was fun and thought-provoking. Then after the World Day of Prayer service at Holy Name, the pandemic shut-down left us with no chance to meet in person again until October. Our members kept in touch by phone and email as much as possible. When we were able to resume meeting in October, it was with COVID protocols of social distancing, wearing masks, and sadly, without refreshments. We met in the sanctuary rather than the parish hall and made the decision to meet at 2:00 pm rather than the evening format. A vote confirmed that the majority preferred to meet in the afternoon, so this change has been adopted. Knowing that many parishes were not having in-person, gatherings, we reached out by letter to the women in other ELCIC churches in our area, inviting them to join our ZLW meetings. We were pleased to welcome a few guests as a result.

Zion Lutheran Women started the year with 45 members. The average attendance at the5 meetings was 17 (including guests). We were delighted to welcome 2 new members Edie Brum and Susan Dupuis in December. We were saddened by the passing of three members in 2020. Memorial donations were made in honor of Mary Brown, Lois Wolfgram and Hilda Klawitter

Our ZLW members recorded a total of 51 visits to Zion's sick and shut-in members during the first 3 months. After that, I know that many phone calls were made to connect with our ZLW sisters. Our card convenor sent 20 birthday cards (to members who are 80 or over) and 4wedding anniversary cards (to members married 50 years or more). There were 10 sympathy cards and 8get-well cards sent as well.

Although the COVID restrictions cancelled the July birthday party at Miramichi, we delivered the cards and gifts, as we wanted the residents to know we remembered them on their special day. On December 9, Ellen and Pam delivered Pointsettias and cards 'to the door' of 12 shut-in members (visits were done on the phone only).

Cheryl Sack and her team of quilters had many items completed before the COVID shutdown, and then she continued quilting at Zion on her own since March 2020. Cheryl prepared a shipment of 7 boxes of items, which included 40 regular quilts, 12 baby quilts, 8 lap robes and 30 baby bundles. Thank you to Smitty's Home Hardware for delivering this shipment to Winnipeg in September. As we have done for the past several years, the ZLW Executive agreed to cover the \$150.00 cost of bags and shipping oversees. As well, two quilts have been donated to residents of Carefor, 2 baby quilts were donated to the food bank for families expecting babies, and 10 receiving blankets were donated to First Step Options. A huge thank you to Cheryl, Jan Scheidt, Arlene Husk, Joan Lehman and Marcella Kuehl for your time and talents on behalf of Zion.

Our monthly meetings are held on the first or second Wednesday of the month (except during the months of July and August). All women of Zion and the community are invited to attend. Offerings are gathered at each meeting. Donations in 2020 were made to St. Joseph's Food Bank, Women's Inter-church Council of Canada (WICC), Christmas gifts for Carefor residents, and St. Vincent de Paul Soup Kitchen.

Treasurers Report for 2020

Well, I think this past year of 2020 "no one" could have predicted. The pandemic of Covid 19 sure has had its effect on the world. Worshipping at church has presented many challenges. I congratulate and applaud our leadership and the many members of our congregation who have worked hard to help worship happen. We will get through this, so we can again immerse ourselves into the work we all share serving God by serving others. As the treasurer I feel very blessed to have such an excellent bookkeeper in Kathy Hoffman. Kathy comes in during her lunch hour on Mondays and inputs the requisitions for paying bills, employee related costs, bank reconciliations and other related matters. Jean Rutz as church secretary ensures all donations are accurately recorded, donation receipts issued, mailings done and all bills and receipts filed in appropriate folders so we can deal with them. A special thanks to both Kathy and Jean, working together to maintain accurate and up-to-date reports and to Michael Lange as assistant to the treasurer for helping me out with the treasurer duties. Please continue to help us by submitting requisitions with receipts, proper payee information and description of items.

Financial Overview:

This past year of 2020 was indeed a very challenging year. Our church is blessed to have so many hard working and generous members. We succeeded in paying all our bills, repairs and other improvements. The Grand piano was also purchased. There are now also enough funds in the Stained Glass Repair Fund. I would ask that you direct your special gifts to the Building Fund to help fund the replacement of the elevator entrance walkway. We were able to send in our full benevolence commitment, supported missions, the food bank and many other local needs. I have listed them in this report so you can get a good idea of how your generosity helps those in need. The total surplus for the 2020 year was \$23,852.68. What contributed to our surplus was the government CERB and CEWS programs, reduced employee and benefits costs and lower operating expense. We would be looking at a deficit of over \$10,000.00 if not for this. Your treasurer and council decided to put \$20,000.00 of the surplus into a general reserve fund. Our regular giving's were down just over 9%. Thank you for all your generosity and support towards keeping our church functioning as it should.

2021 Budget Highlights:

- Our benevolence commitment is budgeted at \$26,000.00.
- Our total budget has increased by \$1,518.08 from 2020.
- Insurance costs have increased.
- Pension Plan, Health and Dental rates increased.
- The Pastor, secretary, and custodial were increased by 1%.
- Changes have been made to the Church Musician contract.

Our budget is realistic and can be supported in comparison to the past year.

Annual General Meeting

February 23, 2020

- **1, 2. Opening Comments:** The meeting was called to order at 11:35am by Council Chair Susan Dupuis. Thanks were extended to the congregational members who stayed for the meeting (60 in total), council members, Pastor Stephen, and the hospitality committee for looking after the kitchen.
- **3. Opening Devotions:** Opening devotions were given by Pastor Stephen beginning with an acknowledgement that we are gathering on Treaty Territory of the Algonquin People.
- **4. Approval of Agenda:** The agenda was reviewed. Changes were made as follows: number 8 (report from National Convention) moved to number 15 (other business); additions included an update on Camp Lutherlyn from Robbie Tremblay under item 12 (Camp Lutherlyn), and a discussion on solar panels under item 8 d (property).

Motion to approve agenda: Michael Lange.

Seconded: Gayle Seegmiller. Carried by congregation.

- **5. Introduction of Council Members:** Susan introduced the council members present: Dan Dole, Jill Kellough, Diane Leeder, Cheryl Sack, Ellen Vandersleen, Wilmer Verch, Rick Gerundin, Patricia Wegner. Excused council members not able to attend were: JoelNieman, Diana Wegner
- **6. Recognition of Outgoing Council Members:** Council terms will be ending for both Dan Dole and Cheryl Sack in March. Susan extended thanks to Dan and Cheryl for both their work and their input at council meetings. Denise Schizkoske has agreed to fill one of the vacant council positions; the other position will need to be filled. There were no volunteers from the congregation present at the meeting.
- **7. Adoption of Reports not requiring discussion:** Corrections were noted in the following reports: no changes noted.

Motion to approve: Carol Boldt.

Seconded: Jaimie MacKinnon. Carried by congregation.

8. Reports:

a) **Minutes of 2018 Annual Meeting** (page 45).Name correction: under Introduction of Council Members, it was noted that "Joel Laymen" should read "Joel Nieman" (p. 45). Motion to approve: Sandra Sell. Seconded: Lorraine Mackenzie. Carried by congregation.

- b) **Pastor's Report** (page 3). Motion to approve: Edie Brumm. Seconded: Candace Rose Smith. Carried by congregation.
- c) **Finance Report** (page 40-41).Gerry Vandersleen reviewed the 2019 financials and the budget for 2020. Gerry brought attention to the various funds and charities that the church supports and to following: **Expenses** benevolence expenses were met for 2019. Committee expenses; utility expenses; operating expenses; payroll and benefit expenses; total; total expenditures.

Revenue- revenue lines were reviewed. Regular offerings are down; other revenue includes the various funds raised with apple pie day, Lenten suppers etc.). Total surplus is \$20 288.43,which includes the carry over of \$7,000.68 from the 2017/2018yearplus \$13,265.00 from 2019 (this is due to the pastors' salary and benefits not being paid for the full year and to the amount of fundraising that was done). The \$7000.68 will be used to balance the 2020 budget and \$13,265.00 will be set aside for emergency use.

Motion to approve the financial report: Larry Seegmiller.

Seconded: Diane Rull.

Budget- budget lines were reviewed. Gerry discussed the organist contract. The contract is a pay for play contract and as the decision was made to no longer continue with Saturday services, the pay per service has been increased to \$200 from \$130 and \$150 (Sat. and Sun.). The pay per choir was also increased to \$1,500.00 per choir. Pastor Stephen is covered by Jan's benefit plan so will not be requiring the church's contribution to a plan. Surplus/deficit of \$0.00.

Discussion: Elaine Metzger had a question regarding the organists' contract, and why the organist is not paid a salary. Elaine was wondering when the decision was made to move from a salary to a contract position. There was concern that we might lose the organist given the discussed changes to the organists' compensation. Gerry explained the remuneration and the increase in amount per play is to compensate for the decrease in services. Susan discussed further to explain that the personnel committee (particularly Debbie Wegner) worked closely with the organist to come to an acceptable and fair agreement. Congregation was satisfied with the response. Brenda Dole had a question re the pastor's salaries...question re difference between 2019 budget for pastor's salary and the 2020 budgeted amount. Susan mentioned that the amount for the 2020 budget for the pastor's salary was made in discussion and agreement with Pastor Stephen (present salary is not per the synod guidelines).

Motion to approve the budget carried by congregation.

- d) **Property Report**: Gerry Vandersleen also presented the property report. The repairs have been completed in the foyer (insurance did not come forth to repair all of the damage); the roof replacement will need to be completed this year. The solar panel discussion included a recommendation to increase the size of the solar panels so that solar panel income will be increased. After a brief discussion, the congregation agreed to move forward with this endeavour. Larry Seegmiller questioned the contract for the present solar panels; Gerry indicated that we have approximately 13 years remaining on the contract. There was also a brief discussion on plans for the empty lot. Decisions will need to be made on what to do with this property. At present, it is being used for storage of snow, which is saving the church \$5000.00-\$6000.00/year on snow removal. After a question from Brent Wolfgram, Gerry provided clarification re the difference between the building fund and the property reserve accounts.
- **9. Cemetery Board Members**: The cemetery committee remains active. The Zion committee members include Jamie Mackinnon, Mark Hoffman, and Dan Dole.

- **10. Auditors:** The auditors remain unchanged. They are Barry Grosskleg, Dan Dole, and Jaimie Mackinnon.
- **11. Endowment Committee:** Endowment committee members remain the same. They include Doug Maliff, Lorraine Mackenzie, and Candace Rose Smith. Candace has completed her term after 6 years of involvement; a replacement will be required. Cheryl Sack has agreed to sit on the endowment committee. Carried by congregation.
- 12. Lutherlyn Camp and Conference Centre Board: Zion members include Diane Hammel, Erica Deloughery, and Robbie Tremblay. Brent Wolfgarm has stepped down from this committee. Robbie presented an update on Camp Lutherlyn and the way the different committee members are involved. Camp Lutherlyn is presently looking for board and committee members. Letters of thanks will be coming to thank those congregations which contributed to Camp Lutherlyn over the past year. The washroom update/project will be done this year (2020) and other capital projects are planned. Camperships are made possible through donations and funds go towards the cost of camp for campers who have financial needs.
- **13. Endowment Fund Vote:** There is presently \$10 345.43 generated for disbursement from the endowment fund. Gerry noted that a financial review was required this past year as per the guidelines and it was done by Cathy Hoffman of Dean Sinclair Chartered Accountants (cost=\$1,243.00). A total of \$9,100.00 will be distributed by vote with the rest remaining in the account for bank fees.

A vote was held to distribute the funds between inside and outside needs. Outside needs were identified as the Robbie Dean Counselling Centre, Renfrew Hospice, Camp Lutherlyn, Music Healing Vets, St.Joseph's Food Bank, John Howard Society for Men, other. Inside needs were identified as ZLC Building Fund, Property Reserve, Organ restoration, other. Paper ballots were handed out to the congregation members present.

Motion to destroy the ballots for the Endowment vote was moved by Scott Lange.

Seconded by: Sandra Sell.

14. Election of New Council Members: Not addressed at this meeting.

15. Other Business:

a) Report from National Convention. Susan Dupuis gave a report of the National Convention, July 11-13, 2019 held in Regina Saskatchewan. The cost of this conference is covered by the National Church. There are a specific # of delegates from each synod that attend and you need to be chosen at the Synod Convention.

Susan Johnson was re-elected as the National Bishop during a full voting process over the course of the convention and each day began and ended with worship.

Medical Assistance in Death (MAID) was discussed: February 6, 2015 was the date that the Supreme Court of Canada ruled that it was no longer a criminal offense for a physician to assist in a death and strict criteria were put in place. Our primary calling as disciples is to say to a dying person "we will support you and journey with you whatever you decide." Paramount to the discussion on MAID is the need to lobby for better palliative care for all and to lobby for quality mental health care.

That the National Church Council approves and recommends for adoption to the 2019 National Convention the following motion: "That the ELCIC National Convention directs the National Church Council to identify, gather and share resources that will support congregations and faith communities in living out the calling to offer spiritual care throughout the sacred journey of life, including birth, dying and death. This will include resources on providing safe space for conversations about dying and death, and resources for worship and prayer. We encourage congregations and faith communities to identify and gather local resources." CARRIED.

Reconciliation with creation: A presentation was made by Dr. Mary Vetter and Dr. David Sauchyn. This revolved around global warming and what we can do to take care of God's world. Small things can lead to big things. We could arrange to have someone from the recycling plant visit to see what we can do better. Stay committed to recycling at home. Ideas were given for people to run with: ie: a

large empty building that could be used as a free store like Habitat for Humanity's Restore.

Reimagining our Church: A full 50 page report was created.

- 1. We agree to ordain deacons.
- 2. We agree to create a liturgy with which to ordain pastors, bishops and now deacons, and each to their particular functions.
- 3. We set out conditions under which deacons may preside at weddings or funerals.

As a church we continue our work of reconciliation with Indigenous Peoples. The theme of this year's convention: Called to Journey Together: The Ministry of Reconciliation.

People of Other Faiths: Presentations were made by people of other faiths. It is important to learn about their beliefs in a proper setting. The news is not the place to learn. Respect was emphasized.

Relationships: We say we are welcoming to all, but is that really true? Discussions included emotional pain regarding gender, gender identity and sexual orientation. This area includes race and ethnicity, indigenous peoples, people with disabilities, and interfaith relationships. The need to respect all people was discussed.
