Also ask if there happens to be an upcoming town hall or opioid summit <u>already</u> scheduled in your State.

If so, make sure to **attend the meeting(s)** and ask your legislator in front of your city town about where they stand on **untreated pain crisis** and what they plan to do to **protect** the rights of chronic pain patients and doctors. **REMIND THEM THAT WE WILL VOTE ON THIS ISSUE IN NOVEMBER!**
