Financial Commitments of Member Clubs

The following is a summary of the financial commitments of all member clubs. It may be used as a check list each season, or as a guide to prospective clubs considering membership of the League.

To be paid prior to season:

LFA Annual Registration Fee inc. mandatory insurance (as at August 2019)	£105
League Entrance Fee	£40

To be paid during season:

Monthly Pitch Fee Instalments to be paid at Monthly General Meetings	Calculated monthly @ £29.50 per club/game
Note: Total pitch fees payable depends on number of actual games played and is calculated each calendar month	
Booking Fee (added to monthly pitch fee instalment)	£2 per game
Monthly Draw (to be paid at Monthly General Meetings)	£6
Player Registration Fee (to be paid March/April General Meetings)	£1 per player
Printing Costs (to be paid March/April general Meetings)	£15

To be paid on match days:

Referees' Fee (per Club)	£15

Other possible expenses:

Result Book	£15
Transfer fees (free if player has not played for previous Club)	£5
Name Change (during season)	£30

All Clubs are responsible for providing; home and away kits, two regulation match balls and an adequate first aid kit

Clubs may be fined by the League for such things as missing meetings or ineligible players. (refer to rulebook/handbook).

The LFA may also fine players or Clubs for offences on the field e.g. red or yellow cards, etc.

Summary of Statutory Fines for Breach of League Rules

Non-attendance of Club representative at a General Meeting	£10
For not contacting League Secretary after non-attendance at a General Meeting	£5
Fielding an ineligible or unregistered player	Fines and point penalties as Management Committee decide
Late kick-off	£5
Failure to phone in match result to Results' Secretary	£5
Incomplete result form	£5
Late result form	£10
Unfulfillment of fixture with notice given 2-7 days before fixture	£10 fine & 1 point deducted
Unfulfillment of fixture with notice given less than 48 hours before fixture	Maximum £50 fine & 3 points deducted
Points may be awarded to the other team if it is deemed that there is insufficient time in the season to rearrange the fixture	

- Each Club will be allowed to request 1 open date per season
