# About the Months of June & July...



**June** is the sixth month of the year in the Julian and Gregorian calendars and the second month to have the length of 30 days. June contains the summer solstice in the Northern Hemisphere, the day with the most daylight hours, and the winter solstice in the Southern Hemisphere, the

day with the fewest daylight hours (excluding polar regions in both cases).

#### June symbols

- June's birthstones are <u>pearl</u>, <u>alexandrite</u> and <u>moon-stone</u>.
- The birth flowers are rose and honeysuckle.
- The <u>zodiac</u> signs for the month of June are <u>Gemini</u> (until June 20) and <u>Cancer</u> (from June 21 onwards).



**July** is the seventh month of the year (between June and August) in the Julian and Gregorian Calendars and the fourth month to have the length of 31 days. It was named by the Roman Senate in honour of the Roman general, Julius Caesar,

it being the month of his birth. Prior to that, it was called Quintilis.

- July's birthstone is the ruby, which symbolizes contentment.
- Its birth flowers are the Larkspur or the Water Lily.
- The zodiac signs for the month of July are Cancer (until July 22) and Leo (July 23 onwards).

### THE PANAMA HAT

The name "Panama hat" often brings to mind images of sunshine and paradise. The story behind the iconic Panama hat goes back to the mid-1800s. Despite the exotic name that has made Panama hats a global fashion sensation for nearly 200 years, they actually originate in Ecuador.

The Panama Hat: An Ecuadorian InventionA true Panama hat is hand woven with toquilla palm fibers by skilled artisans in Ecuador. A majority of Panama hats come from the Ecuadorian province of Manabi which contains the villages of Montecristi and Cuenca. Historically, throughout Central and South America, "Panama hats" were often referred to as "Jipijapas." As its most popular export, Ecuador takes great pride in Panama hats. Since most people feel a Panama hat would logically come from Panama, Ecuador hardly gets credit for the invention or production of the famous hat. In fact, when Panama hats first appeared at the 1855 World Fair in Paris, Ecuador was never mentioned in the World Fair catalog.

#### The Hat Travels to Panama to Strike Gold

Ecuador wasn't a high-traffic tourist destination during the 1850s. As a clever business decision, the hat makers took their stylish accessories to the busy trade center of Panama. There, the hat makers struck gold. They sold hundreds of hats to gold prospectors traveling through Panama on their way to California during the historic Californian Gold Rush. Travelers would tell

people admiring their unique hats that they bought them in Panama. So, the hats quickly became known as "Panama hats."

The Famous Hat of the Panama Canal People have favored Panama hats for their wide brims, comfort, and lightweight straw fibers from the very beginning. During the construction of the Panama Canal that began in the 1880s, hardworking canal workers wore the hats to keep them protected from the heat of the sun. Photographs of Panama Canal workers wearing their special hats quickly circulated around the world, causing people to label the Ecuadorian headpieces as "Panama hats." In 1906, a famous image was taken of President Theodore Roosevelt proudly wearing his hand woven straw hat during his visit to the Panama Canal. Americans have called them "Panama hats" ever since.

People across the world have enjoyed the authentically Ecuadorian hat for centuries. Regardless of their name, Panama hats are a perfect travel accessory with a history as unique as their iconic design.

#### SPEECH & HEARING **Studies show link** between hearing CENTERS loss, mental decline

### Could hearing loss have a link to dementia?

Hearing loss is so common that it's long been considered a normal part of the aging process and no great cause for alarm. But studies from Johns Hopkins University have found links between hearing loss, cognitive decline and dementia. That means that it may be a greater health threat than imagined and that measures as simple as hearing aids could have a huge influence on healthy brain function. "Hearing loss shouldn't be considered an inconsequential part of aging," said Dr. Frank Lin, assistant professor at Johns Hopkins and an otologist and epidemiologist who studies the effects of hearing loss on older adults.

In one study involving nearly 2,000 men and women age 75-84, Lin and his colleagues found that over six years, cognitive abilities (including memory and concentration) of those with hearing loss declined 30 to 40 percent faster than in people with normal hearing. A 2011 study of some 600 older adults found that those with hearing loss at the beginning of the study were more likely to develop dementia than adults with normal hearing. In fact, the more severe the hearing loss, the more likely they were to develop dementia; volunteers with mild, moderate and severe loss were two, three and five times more likely to develop dementia than those with normal hearing.

Another study by Lin and his colleagues found accelerated rates of brain atrophy in people with impaired hearing compared with those who had normal hearing. In addition, they linked hearing loss to "deep episodes of stress, depression or bad mood," an increased risk of hospitalization and an increase in the risk of falls.

The link is backed by other researchers. Dr. Richard Gurgel, assistant professor of otolaryngology-head and neck surgery at University of Utah Health Care, studied more than 4,400 men and women 65 and older; those with hearing loss at the beginning of the study (published in 2014) developed dementia at a higher rate and earlier than those without hearing loss."His research has been fantastic," Gurgel said of Lin's work. "It's energized our field and brought this issue to the forefront. He's been a real pioneer in this area."

Gurgel, Lin and others are now focused on finding out whether hearing loss causes dementia or is related to dementia. "Dementia has so many causes. I think hearing loss could be a very important component, but there are certainly a lot of factors that play into dementia," Gurgel said."Those data (from Lin's studies) are very, very solid," said Dr. Arthur Wingfield, professor of neuroscience at Brandeis University. He called Lin's findings "provocative and interesting.""But if someone has an age-related hearing loss, they shouldn't say, 'Oh my goodness, I'm going to get Alzheimer's disease.' It's not a one-on-one, perfect correlation," Wingfield said. "There are many people who develop an age-related hearing loss and live a long life, cognitively intact. But the correlation (between hearing acuity and cognitive function) is there."

### A rather fine commencement address by Chief Justice John G. Roberts Jr.

It was the ninth-grade commencement address for the Cardigan Mountain School, an elite boarding school for boys grades six through nine. Sitting up front under a large white tent as John Glover Roberts Jr. took the stage was graduating student John Glover Roberts III.

In Canaan, N.H., Head of School Christopher Day said, the 17th chief justice of the United States would always be known as the dad of "our Cardigan Cougar Jack."

Roberts's commencement address was not publicized in advance, but it was recorded by the school, uploaded to YouTube and isslowly gaining attention. One person wrote, "I'm a Democrat and I can't stand the guy's views, but I was in tears."

There is nothing about the Supreme Court or the law in the short speech, although each graduating Cougar received an autographed, pocket-size Constitution along with his certificate.

Instead, the address was personal, understated and popular probably because it touched on universal themes, such as a parent's worry about whether he or she is making the right decisions for their child.

Driving through the gates after leaving a student at Cardigan, Roberts said, parents travel a "trail of tears" to an "emptier and lonelier house."

Roberts is considered one of the Supreme Court's better writers, and his public addresses show a quick wit and professional timing. He first asked the Cardigan students to turn and applaud their parents and others who had guided them.

He joked that he would later be able to report that his speech was "interrupted by applause."

Success, he reminded them, comes to those who are unafraid to fail. "And if you did fail, you got up and tried again. And if you failed again, you got up and tried again. And if you failed again — it might be time to think about doing something else."

Roberts said commencement addresses customarily wish graduates success. He thought it better for them to experience challenges.

"From time to time in the years to come, I hope you will be treated unfairly," Roberts said, "so that you will come to learn the value of justice."

Betrayal "will teach you the importance of loyalty." Loneliness will instruct people not to "take friends for granted." Pain will cause someone "to learn compassion."

"I wish you bad luck — again, from time to time — so that you will be conscious of the role of chance in life," Roberts said. "And understand that your success is not completely deserved, and that the failure of others is not completely deserved, either."

"But you are also privileged young men, and if you weren't privileged when you came here, you're privileged now because you have been here," Roberts said. "My advice is: Don't act like it."

He urged them, at their next school, to introduce themselves to the people "raking the leaves, shoveling the snow or emptying the trash." Learn their names, smile and call them by name. "The worst thing that will happen is you will become known as the young man who smiles and says hello," he said.

Another thing:

"You've been at a school with just boys. Most of you will be going to a school with girls," Roberts said.

Long pause.

"I have no advice for you."

In his speech, Roberts quoted Socrates and, not surprisingly, he ended it with the words of "the great American philosopher, Bob Dylan."

Roberts has quoted Dylan in judicial opinions, and he's not alone. The New York Times a few years ago noted a study that found Dylan the mostquoted songwriter in judicial opinions, and said Roberts had "opened the floodgates" by quoting the Bard of Minnesota in a 2008 dissent.

The song he quoted at the commencement speech was "Forever Young." Roberts is an unusual parent. Now 62, he and Jane married rather late in life. Their contemporaries are welcoming grandchildren, while they have two high-schoolers, Jack and his sister Josephine.

"May you build a ladder to the stars

And climb on every rung

May you stay forever young."

The wishes expressed by Dylan for his son, Jesse, are "beautiful, they're timeless, they're universal," Roberts said.

But the phrase that gives the song its title and refrain — forever young — is unrealistic, the chief justice said. It can't come true.

"That wish is a parent's lament," he said.
