Application Process

Congratulation, by receiving this application you have shown interest in our Van's Aircraft RV12 Build Program and have either attended an Open-House event or were personally briefed by an authorized Southern Arizona Teen Aviation staff member on the eligibility requirements, benefits of our program and time commitment expected of you.

The following describes the application process. Please be patient, this process can take a couple weeks for us to process and select the students for the coming school year's program.

Application Submittal

It is very important that the student and parent(s)/guardian take the time to carefully read and complete the application. Applications that are not complete, or are not legible, could result in the rejection of your application.

If your application has been rejected you may have an opportunity to correct it and resubmit it for the same year as long as the enrollment period is still open. Student that are rejected are encouraged to reapply for next year's build program.

Student Evaluation

During the interview process, you will also have an opportunity to verbally express your interest and commitment level to the program and have an opportunity for Q&A with staff. Students' should expect staff to ask probing questions regarding their interest/commitment to Southern Arizona Teen Aviation, including any follow-up questions pertaining to responses provided in the student's application.

Student Selection Notification

Southern Arizona Teen Aviation will email each student notification on whether they have been selected for the school year's program. Student's not chosen can reapply next year as long as they still meet eligibility rules. We will also create a waiting list of qualified students. Should anyone drop out prior to our next open enrollment they may be invited to join the aircraft build.
