The Johnston Town Council held their regular Council Meeting at 6:30 pm, Monday, November 13, 2023, at the Johnston Municipal Building. #### **Public Comments:**

Annette Holloway, a business owner in the town, presented a proposal to conduct a "Unity Weekend" in January. The weekend will be in honor of Martin Luther King. Mayor Holmes asked that Mrs. Holloway put her request in a letter detailing the event so that the town can provide the necessary support.

Several other citizens provided comments concerning yard debris, violence, shootings, poor street lighting, loud music, and speeding. Mayor Holmes advised everyone providing comments that the information would be taken for follow-up.

Hearing no more comments, Mayor Holmes closed the public comments and moved into further business.

- Councilman Berry reported 163 dispatch calls for the Police Department, 90 of those being traffic stops and 61 Patrol checks. Berry also expressed that he was glad to see Chief Perry back at work, the department changed the "Assistant Chief" position name to "Captain", which Justin Gentry currently holds. The Police Department hired 2 new officers, Daniel Winston and Crystal Pierce.
- Councilman Felder commended Public Works on their work ethic and reported that they hired a new employee.
