

A VISIT WITH JUDITH JOHNSON

THE TIME IS RIGHT TO CHANGE THE LEGISLATION.

I recently had the opportunity, along with five other NYSUT leaders, to discuss some items that are most important to our members with Regent Judith Johnson. Ms. Johnson, appointed to the Board of Regents in April 2015, hit the ground running, opening up new important dialogues with educators and legislators in an attempt to move us forward. I saw firsthand her competence and strength as a leader during her tenure as acting superintendent here in Mount Vernon. Since her arrival, the Board of Regents has shifted to a much more progressive, educator based position on many, if not all, of those items within their purview.

The Regents are on the right track, but much of what we need to address can only be done through a change in "statute." For the Regents to enact a more common sense approach to student testing and teachers' evaluation (APPR), they will need additional flexibility added to the law. I bring this to your attention because the APPR laws begin to really count in 2019 and 2020. Between now and then, we will need to pressure the governor and the state legislature to make changes in the law to include added flexibility that will once again allow for greater local control.

Here, in this district, we can push our local legislators to support these changes, but each of us must do so in our home districts as well. We should consider supporting the opt-out movement in our local school districts. We must demand that our local representatives support "greater local control" and the removal of student scores from the teacher evaluation process. Together, we must show support for greater flexibility for the Board of Regents to move New York State from failed education policies to ones that are based more on student growth than state exams.

The time is right to change the legislation and to support quality education and those who believe in it.

YOUR UNION, YOU'VE EARNED IT, SUPPORT IT!

Earlier this year, the United States Supreme Court received briefs from the parties in the Janus v. AFSCME court case. This is one of several cases being used to try and weaken unions across this country. The court is expected to rule before the summer break. Although this is not a New York case, nor is it about a teachers' union, its finding will have a profound effect on all union membership.

Half the states in our country are presently "right to work states," which really means they have no rights at all. The other half, including ours, has collective-bargaining rights and "fair share fees." Not having these guaranteed rights and fees would likely tip the balance of power towards management, changing our lives and working conditions as we know them. When the ruling comes down, we will either continue to have these rights that we have earned, awaiting the next challenge; or, it will be time for all of us to redouble our efforts, keeping our union strong and viable as our united voice against power.

Typically, right to work states limit "fair share" or agency fees. This severely reduces funds available to the unions on which they rely to support the services they provide. This results in lower wages, weakened contracts, and in many cases the dissolution of pension rights and benefits that we have grown to expect. The attacks on our rights are funded by private corporations with deep pockets who have the most to gain. Public employees served by unions in states with collective bargaining rights are in their way. If these

DISTRICT WIDE LESSON PLAN COMMITTEE

The MVFT has appointed a Lesson Plan Team to meet with district administrators as agreed upon in the June 2017, Teacher Memorandum of Agreement. The MVFT Lesson Plan Team, facilitated by MVFT VP Carene Domato, includes: Laura Mason, MVFT Chairperson; Francia Mendoza, Graham School; Thalia Langley, Hamilton Elementary; Donald Emerson, BTMS; Jason Stone, AB Davis MS; Anita Amieiro, MVHS, and Jessica Pizzuti, Thornton HS.

The MVCSD Lesson Plan Team facilitated by Dr. Claytisha Walden, Associate Supt. of C&I, includes: Charles Brown, AP of BTMS; Daniel Brady, AP of Thornton HS; Jacqueline Green, AP of Williams; Marc Molina, AP of Lincoln, and Colleen Crawford, Principal of Columbus.

The charge of the District Lesson Plan Committee is to make recommendations to the MVFT and the district pertaining to lesson plans. At this time, we have only been able to meet twice with the district. Thus far, we have brainstormed a list of lesson plan components, and perused a number of lesson plan templates.

Throughout our discussions with Dr. Walden, we have come to a consensus that lesson plans are at the discretion of the teacher as stated in the teacher contract. For this reason, the LP committee will be recommending a number of optional lesson plan formats. We have asked our building representatives to ask teachers to submit any lesson plan format that they have found to be effective. The MVFT LP Team wants to make sure that all our teachers have the opportunity to voice their opinions in regard to daily planning.

The MVFT LP Team created an anonymous survey that was emailed to all teachers on February 7th, by Dr. Walden, who also put together a survey with parallel questions for the administrators. We hope that all of our teachers will take the time to complete the survey and be honest with the responses. We will then have an opportunity to discuss and compare the results of both the teacher and administrator survey at our next District LP Committee meeting.

20/20 ACADEMIC VISION UPDATE

At the January 9, 2018, Board of Education meeting at Graham Elementary School, Superintendent Hamilton presented an update to the MVCSD 20/20 Academic Vision. The report moves up the Pre-K through 8 reconfiguration and the implementation of theme based high schools beginning in September 2018. There were also construction updates and improvements to our infrastructure. In September, Traphagen, Williams, Columbus, and Pennington will add 1 full day Pre-K class. In 2019, Columbus and Holmes will add another full day class while Lincoln adds 2 full day classes. In 2020, Hamilton and Grimes will have two full day Pre-K classes and the district will be providing Pre-K education to about 708 students.

Presently, Graham and Pennington are K-8 schools. Rebecca Turner (Pre-K-5) and Benjamin Turner (6-8) serve as a K-8 campus. Beginning in September 2018, Columbus, Grimes, Holmes, Lincoln and Parker will house 7th grade students. In fall 2019, Hamilton, Traphagen and Williams will begin the same transition. The transition to K-8 also signals the end of Davis middle school which will house only 8th graders in the fall.

Great things are happening at the high school level. We will now have three theme based high schools. Mount Vernon High School will become a comprehensive school with a focus on CTE (Career Technical Education), sports, an IB (International Baccalaureate) program and classes in the Humanities. The Performing and Visual Magnet School moves from Mount Vernon High School to the newly renovated Thornton High School building. The present Thornton High School will be phased out leaving only 11th and 12 graders in the fall and the last graduation happening in June 2020. Davis Middle School will become the new STEAM high school in September starting with grades 9 and 10. Current 8th and 9th graders filled out high school choice forms last month. The complete MVCSD 20/20 Vision update can be found on the district website.

This is certainly an exciting time to be a teacher, student, staff or community member in Mount Vernon.

challenges in the courts can damage us enough so that we no longer can bargain successfully for a living wage, benefits, protections like seniority and tenure or if they can undermine our pension rights, then corporate employees will be less likely to demand or win those types of compensation for themselves. Many of our members are too young to remember when all workers had pensions! Not so today! If this case goes the wrong way, we will not retreat, but we will need the support of all our members in order to continue to provide the benefits and support that we do today.

Writing this article made me think that perhaps a reminder of some of the things the union does for its members might be in order. You are all members of the MVFT, NYSUT, NEA, AFT and the AFLCIO; these organizations represent

you at the local, state and federal levels. Locally, we provide a full time office staff to address your needs in a timely fashion. We negotiate contracts, represent members in disputes or grievances, provide benefits and protections, and advocate and lobby to support your pensions and working conditions. KNOW YOUR CONTRACT ~ SICK DAYS

We often get a lot of questions that can be answered quite easily by opening up the contract or recently agreed upon MOA. Both documents for teachers, teaching assistants and security can be easily found on the district website under Human Resources/Contracts and on the MVFT website www.mvft.org.

Since the flu season has hit us so hard this year, I would like to remind all of our members to look more closely at the "Attendance Review Policy" agreed upon for both teachers and teaching assistants. For your health and for the record: go see a doctor if you are going to be out for more than a couple of days.

For those who have used very few sick days, this will be the first year that you may be eligible for a \$500 incentive at the end of the year!

According to the Teacher: MOA Article II: Leaves of Absence

Teaching Assistant MOA: Article III: Leaves of Absence,

Security MOA: Article IV

THE SICK/PERSONAL LEAVE INCENTIVE PROGRAM:

"Effective July 1, 2017, in the event a unit member uses 7 or less personal and/or sick days in a year (9/1-6/30) said unit member shall be eligible for a payment in the amount of \$500 at the conclusion of each qualifying school year. Unit members must work a full school year in order to be eligible for said payment. Those on unpaid leave of absence for any period of time shall be ineligible for said payment."

Please be aware that the district will be relying on the daily attendance roll sent in by your building attendance secretary. The district management system, AESOP/Frontline, will not be used to determine who is eligible to receive the incentive. The MVFT has reminded its members how important it is to keep records of your absences, as we have witnessed many discrepancies between what has been recorded on AESOP, our end of the year APPR Form, and by the school's attendance secretary.

For the purposes of this incentive, it is in your best interest to request your recorded absences from your attendance secretary and to make this request via email and cc your building administration. If there is a discrepancy, be sure to request that it be changed via email and follow up with your secretary until the record of absences has been corrected.

Also, please note that bereavement days do not count against for this incentive. They are not considered personal or sick days, and should be recorded as bereavement.


