

**Junior Goats (RepichEd LLC) – Volleyball Player Waiver and Release of Liability & Assumption of Risk Agreement**

I acknowledge that I have registered my child (either myself or my child, as applicable, shall be referred to as the “Player”) in one or more lacrosse programs organized by Junior Goats, a trademark under RepichEd LLC, such programs will be referred to as Junior Goats. I agree to provide this release and waiver of liability of RepichEd LLC and Junior Goats in exchange for the opportunity for the Player to participate in volleyball. This waiver and release shall remain effective for so long as, and at any time that, the Player participates in any Junior Goats programs.

**Representations:**

I hereby represent that the Player is physically and mentally able to participate in lacrosse and has no health problems or physical or mental conditions that would present a risk to the Player or others.

**Insurance:**

I represent that the Player is covered by comprehensive medical insurance necessary to provide and pay for all costs on medical treatment (including transportation costs associated with obtaining medical care).

**Acknowledgment of Risk of Injury:**

I understand, and the Player understands, that participating in volleyball can lead to common injuries including, but not limited to rolled or sprained ankles, bruises and floor burn, knee problems, shoulder injuries, jammed fingers, wrist injuries. More serious, but less frequent injuries such as broken bones, concussions, heart attacks, strokes, paralysis and death may also occur. These injuries, and others, may result from such incidents as, but not limited to, rapid change in direction, diving for a ball and sliding on the floor, colliding with another player, the ground or the net, getting hit by a volleyball, and improper footwear.

By enrolling the Player in the Junior Goats programs, I certify that the Player is aware of all the inherent dangers of participating in volleyball. I further certify that the player is familiar with the rules of the game and of the court and will to the best of his/her ability play under control and avoid injury to himself/herself and other persons playing the game.

**Assumption of Risk:**

In exchange for the right for the Player to participate in the Junior Goats program, I hereby assume all risks associated with volleyball, including the risk of serious bodily injury, death, and/or property damage and I hereby agree not to sue Junior Goats (RepichEd LLC), nor their sponsors, directors, officers, employees, coaches, volunteers, instructors. I release Junior Goats (RepichEd LLC) from all liability claims or demands of every kind which may arise out of the player’s participation in activities arranged by Junior Goats.
