COVID-19 Announcement

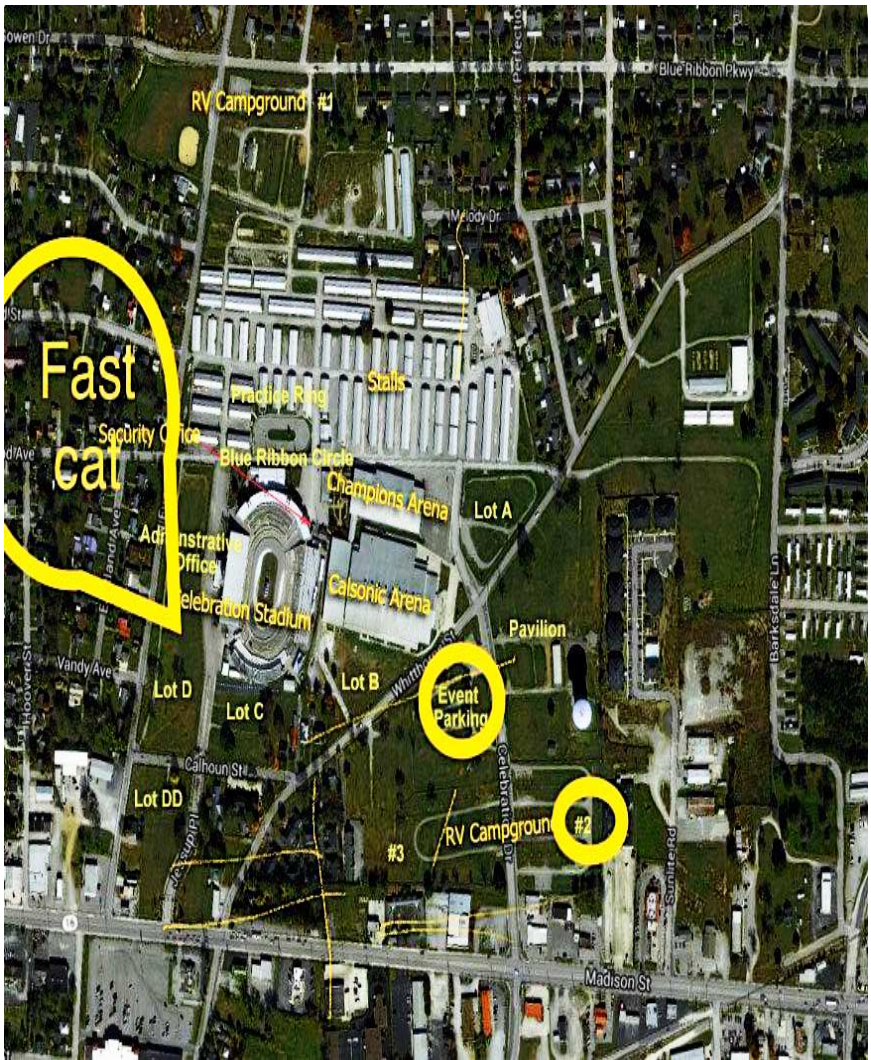
