How to Apply

1 Verify Eligibility

- You must be a current ComEd residential delivery service customer.
- Appliance must be ENERGY STAR certified (excluding induction cooktops and ranges) and meet the Rebate Eligibility Requirements on page 2.
- Higher rebate amounts may be available for qualifying customers. Eligibility is determined by household income among other qualifiers. If you are interested to learn more about your eligibility, please call **855-530-5783** or visit ComEd.com/Eligible.

2 Complete Application

- Check your application to ensure it is correct, legible, complete and signed before submitting.
- If you are applying for multiple rebates, submit an additional copy of page 2 for each rebate.

3 Submit Application

- Include a legible copy of the entire sales receipt, which includes product information for each appliance purchased, purchase price, purchase date and retailer business information.
- Make a copy of the application and receipt for your records.

4 Receive Rebate Payment

- After your rebate application is reviewed and approved, you will receive a rebate check in approximately four weeks.

Rebate Eligibility Requirements

1. You must be a current ComEd residential delivery service customer.
2. Appliance must be purchased by December 31, 2024.
3. Application must be submitted within 60 days from purchase date or by February 28, 2025, whichever comes first.
4. Each ComEd residential service customer is limited to two air purifiers, dehumidifiers or water dispensers, and one clothes washer, electric clothes dryer, heat pump clothes dryer, induction cooktop and ranges.
5. Appliance must be ENERGY STAR certified and meet the above stated requirements to qualify for a rebate. This excludes induction cooktops and ranges.
6. ENERGY STAR certified appliances must be new and purchased in Illinois, or the buyer must demonstrate having paid the applicable Illinois sales and use tax.
7. The rebate paid will not exceed the purchase price (excluding taxes, shipping and installation charges) of the appliance. Rewards/points may apply. Check with retail location.
8. Cannot be combined with other ComEd Energy Efficiency offerings.
9. Rebate eligibility requirements are subject to change without notice, including early termination of this promotion.
