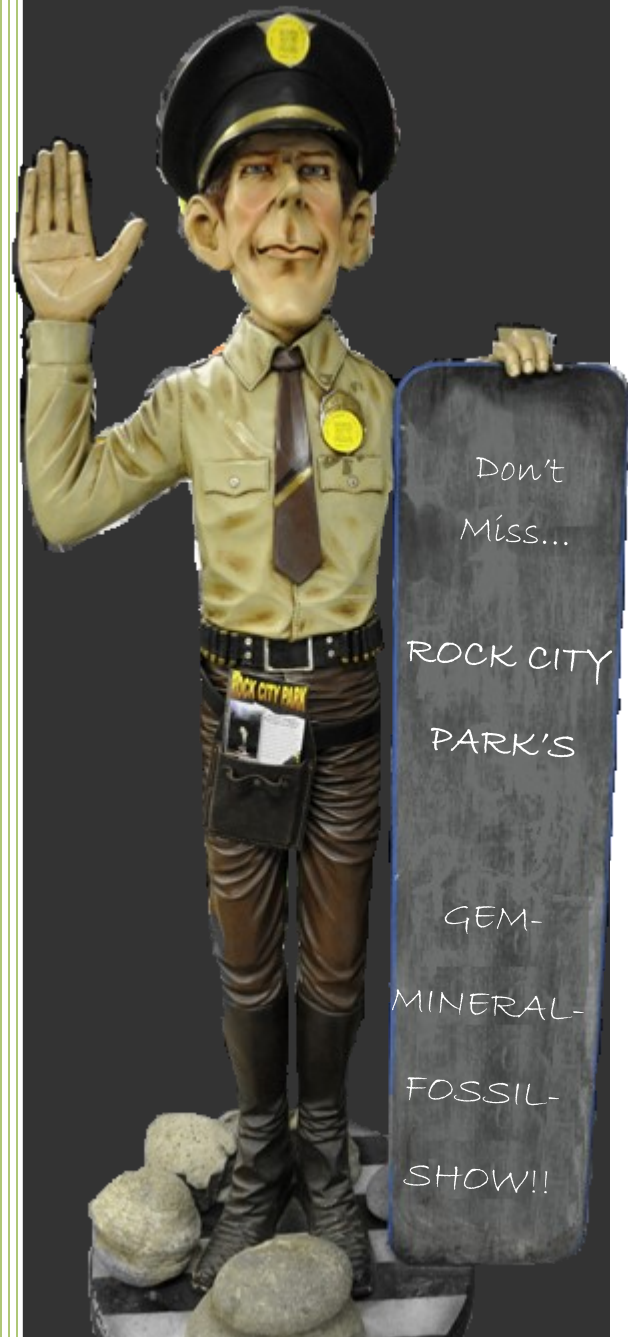

Once these spaces are taken, vendors are encouraged to bring their own table/ tent. Early set up begins at 1:00 p.m. on Friday, October 3rd. Vendors will also receive 4 free park passes that can be used during show days.

We also would like to invite Gem & Mineral Clubs to set up informative and educational displays. We are hoping you will participate.

Rock City Park is open daily May – October, 10:00 a.m. - 5:00 p.m. Our hiking trails wind through one of the largest natural displays of quartz conglomerate in the world and attract thousands of global visitors each year.

ROCK CITY PARK GEM-MINERAL-FOSSIL SHOW Vendor Guidelines

Vendor registration and cancellation:

Vendors are asked to accurately provide all information requested on this form, sign and be received including \$50 registration fee in a timely fashion by Cynthia and Dale Smith at any of the contact information provided on page 5. Any cancellations must be received 1 week prior to the show date.

Set-up and Take Down:

Early set up begins at 1:00 p.m. on Friday, October 3rd. Tear down can begin any time after 4:00 p.m. on Sunday, October 5th but must be completed by 6:00 p.m.

Vendor Space:

Rock City Park will provide vendors with one 6 foot table and 2 feet of available space on either side. All vendor booth spaces are set in indoor / outdoor covered areas and include one 6ft. table. Additional table rentals are available at \$10 per 6ft. table. Vendor rates are the same for all vendors and are good for entire Gem Show.

Vendors are expected to provide your own chairs, lighting and other supplies needed to personalize your space for Gem Show. Electricity will be provided. Please specify what type of electrical needs you have.

Vendor Wares:

Items for sale may include rocks, minerals, fossils, shells, jewelry, cut and uncut stones, mining paraphernalia and tools, crafts/artwork, books, and magazines as long as it is related to our natural earth.

All vendors are asked to use discretion when selling your items. Rock City Park reserves the right to prohibit exhibits if deemed inappropriate or not in keeping with the positive, family atmosphere of Rock City Park.

Vendors are expected to know your merchandise. Vertebrate fossils and any fossils from China and other countries that do not allow export will be prohibited. Rock City Park prides its self in its good reputation of quality and trust.

Vendors are expected to provide a copy of resale permit or business license and remit sales tax to the state of New York. New York Sales tax is 8 percent. If you have any questions regarding Sales Tax please contact Cynthia and Dale Smith by using the contact information found on page 5.

The Vendor agrees to obtain and maintain in force, throughout the Gem-Mineral-Fossil Show, comprehensive general liability insurance against any loss, liability, or damage on, about or relating to Gem Show, with limits of not less than \$300,000. The Vendor shall furnish Rock City Park with a certificate of insurance with written evidence that premiums for insurance have been paid, prior to the commencement of Gem-Mineral-Fossil Show. In the event that Vendors do not show proof of insurance prior to Rock City Park's Gem-Mineral-Fossil Show, all Vendors are required to acknowledge, sign and submit the Waiver and Release of Liability Form provided by Rock City Park on page 7 of Registration Form.

Vendor Parking and Park Passes:

Vendors will receive a free parking pass as well as 4 free park tickets valued at \$8.00 a piece. Park Passes can be redeemed through the Rock City Park general season beginning May through October, 9:00 a.m. – 5:00 p.m.

Security:

Rock City Park is not responsible for lost, stolen or damaged merchandise. Vendors are asked to never leave your booth area unattended. Do not leave money out where it can be spotted. Above all use common sense.

During off hours all park gates are closed and locked. A security alarm system will be activated throughout park building.

Food and Entertainment:

During our 17th annual Gem-Mineral-Fossil show a food vendor will be on hand offering fresh cider and hot food items.
