**Release and Waiver:** I wish to participate in the MBBL bocce tournament play (hereinafter "MBBL Tournaments"). In consideration for being permitted by MBBL to participate in the MBBL Tournaments, I hereby waive, release, and discharge any and all claims for damages for personal injury, death, or property damage which I may have or which may hereafter accrue as a result of my participation in the MBBL Tournaments. This release is intended to discharge, in advance, MBBL and its agents, officers, officials, Board of Directors, employees, and volunteers from and against any and all liability arising out of or connected in any way with my participation in the MBBL Tournaments, even though that liability may arise out of negligence or carelessness on the part of MBBL and its agents, officers, officials, Board of Directors, employees, and volunteers.

I understand that the MBBL Matches may be of a hazardous nature and/or include physical and/or strenuous exercise or activity; that serious accidents occasionally occur during the MBBL Matches; and that participants in the MBBL Tournaments may sustain mortal or personal injuries and/or property damages as a consequence thereof. Knowing the risks involved, nevertheless, I have voluntarily applied to participate in the MBBL Tournaments, and I hereby agree to assume any and all risks of injury or death and to release and hold harmless MBBL and its agents, officers, officials, employees, and volunteers that through negligence, carelessness, or any other act or omission might otherwise be liable to me. I further understand and agree that this waiver, release, and assumption of risks are to be binding on my heirs and assigns.

**Hold Harmless:** I further agree to indemnify and to hold MBBL and its agents, officers, officials, employees, and volunteers free and harmless from any loss, liability, damage, cost, or expense which they may incur as a result of any injury and/or property damage that I may sustain while participating in the MBBL Tournaments.

**I have carefully read this agreement, waiver, and release and fully understand its contents. I am aware that this is a release of liability and a contract between me and MBBL, and I sign it voluntarily.**
