This release is intended to discharge, in advance, MBBL and its agents, officers, officials, Board of Directors, employees, and volunteers from and against any and all liability arising out of or connected in any way with my participation in the MBBL matches, even though that liability may arise out of negligence or carelessness on the part of MBBL and its agents, officers, officials, Board of Directors, employees, and volunteers.

I understand that the MBBL Matches may be of a hazardous nature and/or include physical and/ or strenuous exercise or activity; that serious accidents occasionally occur during the MBBL Matches; and that participants in the MBBL matches may sustain mortal or personal injuries and/or property damages as a consequence thereof. Knowing the risks involved, nevertheless, I have voluntarily applied to participate in the MBBL matches, and I hereby agree to assume any and all risks of injury or death and to release and hold harmless MBBL and its agents, officers, officials, Board of Directors, employees, and volunteers that through negligence, carelessness, or any other act or omission might otherwise be liable to me. I further understand and agree that this waiver, release, and assumption of risks are to be binding on my heirs and assigns.

Hold Harmless: I further agree to indemnify and to hold MBBL and its agents, officers, Board of Directors, officials, employees, and volunteers free and harmless from any loss, liability, damage, cost, or expense which they may incur as a result of any injury and/or property damage that I may sustain while participating in the MBBL matches.
