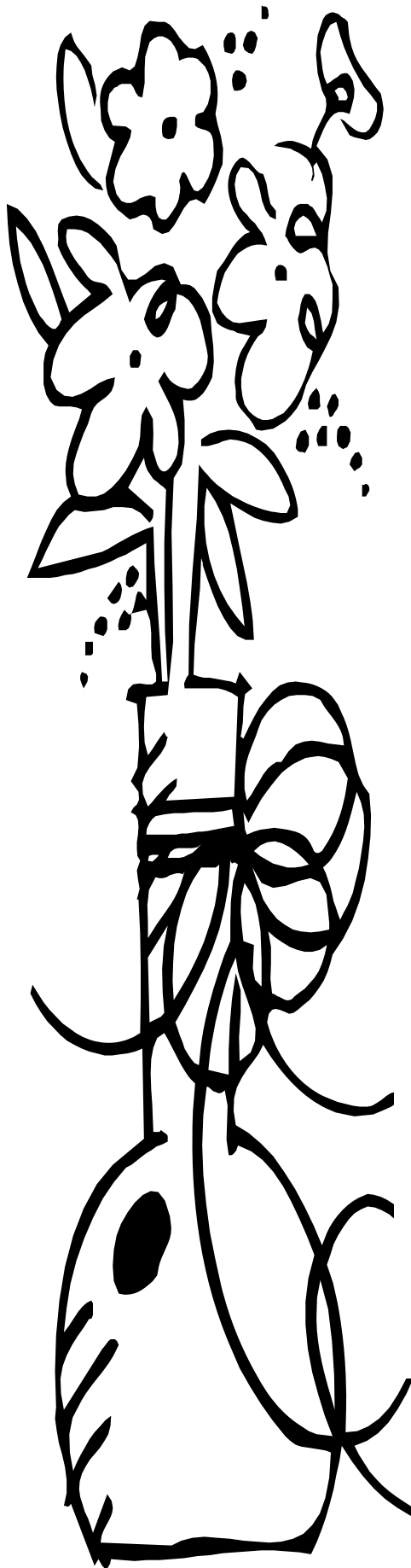

GARDEN OF THE MONTH

RULES & REGULATIONS



- 1 - The purpose of this contest is to promote gardening and the beautification of our neighborhoods. The Garden of the Month Contest is open to private residents of the Spokane County.
- 2 - This contest is scheduled to run in June, July, August, and September. All entries received for a certain month will only be good for that month. One entry per a month. Enter as many monthly contests as you wish in the growing season. Only one Garden of the Month contest winner per a garden or household please.
- 3 - Each contest will conclude by the 15th day of the month (Jun thru Sept) and monthly contest winner will be announced in Spokesman-Review and www.tieg.org.
- 4 - Only 5 gardens will be chosen monthly from entries to be judged any given month. Contest entrants agree to a tour of their garden by judges (usually around 3rd weekend of month entered), an interview by newspaper staff, and consent to have photos taken of their garden for possible publication purposes in the newspaper.
- 5 - The decision of the judges is final and arbitrary.
- 6 - All taxes are the responsibility of contest winner.
- 7 - The selection committee will be members of The Inland Empire Gardeners. In case of a tie or if a decision cannot be reached, the winner of the monthly contest will be determined by the head of the Garden of the Month Selection Committee.
- 8 - The monthly winner will receive recognition in the Spokesman-Review; an annual membership in The Inland Empire Gardeners and an engraved, keepsake stepping stone; and a gift certificate from NW Seed. Winners will also be posted on www.tieg.org.
- 9 - Entries and photos become the property of The Inland Empire Gardeners and will not be returned.
