

Rio Vaqueros Meeting Minutes

Call to Order

President Carl McCleskey called the meeting to order at 17:31. The Pledge of Allegiance was recited.

Previous Minutes

Secretary Carol Whitney read the minutes from the August 28, 2025 meeting.

Treasurer's Report

Treasurer Carol Whitney presented the treasurer's report.

Old Business

Paint

Business Cards/Flyers

- Carol presented three proof options to the members present for business card design. The consensus was to go with proof-2. The red one.
- Scott Costigan made a motion to approve purchasing 250 cards and to allocated funds not to exceed \$50. Gina Roberts seconded. Motion passed with unanimous yes vote.
- Carol will get the cards ordered from Vista Print.

Liability Waiver

- Carol brought a proposed waiver rough document for discussion. Members agreed to review and discuss at next meeting.
- Gina commented that the wording with respect to ammunition should be changed from “hand loaded” to improperly loaded to cover any type of ammunition.

Engle Shooting Site Road Improvements

- A lengthy discussion was had kicking around ideas to improve the very rough and rutted section of the access road to the Engle shooting site.
- Scott Costigan has explored costs of getting a load of rock delivered out to the site. Estimates are that about 20 cubic yards of large rock would be required. Cost would be approximately \$500-\$700.
- Carl McCleskey mentioned that we may potentially have two concrete culverts available to drop into the rather substantial ditch at the site.
- No definite course of action has been decided at this time. Further investigation is pending.

New Business

Rifle Range Vandalism

- Some idiot(s) have damaged one of the support beams for the shade structure at the rifle range. Probably backed into it with a vehicle.
- Carl McCleskey indicated that it will require cutting off the existing section of damaged 4” square tubing, welding on a new section and replacing the concrete.
