Terms and conditions: At least a 50% payment is to be returned with this form. Booking will be secured when payment is received. Once payment has cleared a receipt will be sent to the client. By sending a payment you are agreeing to the terms and conditions set. Balance is to be paid NO LATER than one week prior to the event. Payments are non-refundable. 10 approx. children can be painted in one hour. The artist will stop work at the scheduled time. If additional hours are requested then payment will need to be made immediately. The client will be expected to pay the full booking fee even if the uses the artist for less time than booked for. If changes are agreed to the time, date or location it is the responsibility of the client to confirm these changes in writing. Artist is not liable for any allergic reaction to paints. Anyone with skin allergies or sensitive skin should either not participate or have the artist perform a patch test at the beginning of the event. We will not paint anyone who appears to be suffering from colds, cold sores, conjunctivitis, impetigo, eczema, open wounds, any infectious skin conditions or appear to be sick in any way. Artist will use reasonable care but they are not responsible for damage to clothing or property. The artist uses only safe approved products. The client agrees to pay for any accidents or damage caused by pets or guests to the artist equipment or supplies. Artists are to have a 5-10 minute break every two hours. Artist only presents as a painter and will not supervise children. The behaviour and safety of the children is the responsibility of the parent/carer. Client must provide assistance to watch equipment while loading/unloading and during breaks. Client will be responsible for any parking fees or provide parking at venue. There is a 2 hour minimum. (unless agreed upon otherwise). Entertainers must be set up out of the sun and weather.
